ORDINANCE NO. 1371

An Ordinance accepting the dedication of the Archer-Rardin Subdivision to the City of Athens, Ohio and confirming the dedication of the streets

WHEREAS, on the 28th day of February, 1951 Raymond C. Rardin, John D. Rardin, and Golda A. Archer presented the plat and dedication of the Archer-Rardin Subdivision to the City of Athens, Ohio which plat and dedication was duly accepted by the Council of said City of Athens, Ohio by Ordinance No. 1093 and dated March 19, 1951 and later was recorded in Plat Book No. 7, page 235, in the Recorder's Office. of Athens County, Ohio, and

WHEREAS, Gaynell Rardin, Beatrice Rardin, and Harry R. Archer each owned an undivided one-sixth (1/6) interest in said property, and

WHEREAS, by misadvertence the said Gaynell Rardin, Beatrice Rardin and Harry R. Archer failed to join in the dedication of said streets in regard to said subdivision, and

WHEREAS, they have now presented dedication of their interests in said streets to the said City of Athens, Ohio BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATHEMS, OHIO:

SECTION I

That the interests of the said Gaynell Rardin, Beatrice Rardin and Harry R. Archer in the said streets in the Archer-Rardin Subdivision be, and the same are approved and accepted and the dedication to public use of the streets shown thereon be, and the same is hereby accepted and confirmed and the Recorder of Athens County, Ohio is authorised to note such dedication on said Plat Book No. 7, page 235.

SECTION II

That this ordinance shall be in full force and effect from and after the earliest period allowed by law.
