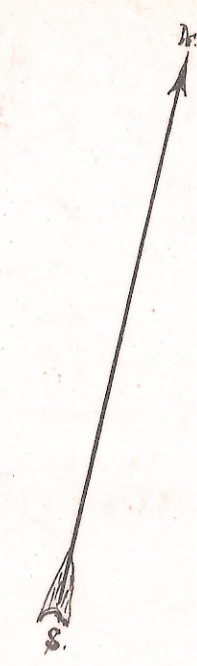

DESCRIPTION.

Beginning at the N.E. Cor. Fraction 3. Thence S. 85° E a distance of 2000 Lineal Feet To Land Thos. Biddison. Thence North 5° E. a distance 66 Lineal Feet. Thence North 85° W. a distance 305 Lineal Feet. Thence North 13° W. a distance 628 Lineal Feet. Thence North 85° W. a distance 2215 Lineal Feet to center Creek. Thence South Westerly with meandering center creek to an alley. Thence South 15° E a distance 473 Lineal Feet. Thence North 88° E to the N.E. Cor. Fraction 3 place of beginning containing 1 street, 2 alleys and 28 lots,

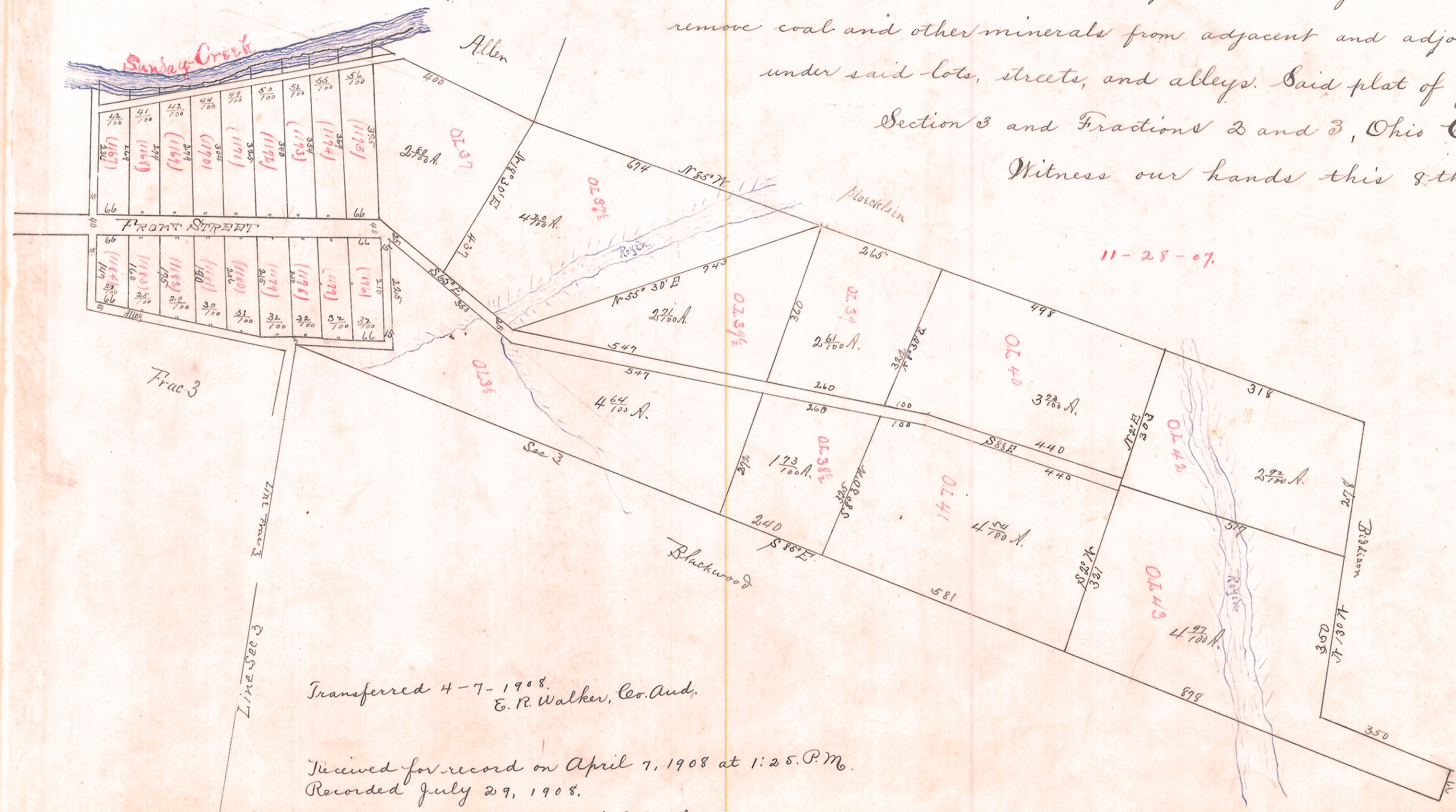
