Situated in the City of Athens, Athens Township, County of Athens and State of Ohio and being Inlot N^o 845 in Hudson's Addition to the City of Athens, containing 3.7898 Acres and being the tract conveyed to Fred W. Wheaton and Gene E. Wheaton by Deed of Record in Deed Book 342, Page 383, Record of Deeds, County of Athens, Ohio.

Said 3.7898 Acres are laid out into 35 (Thirty-Five) lots, numbered 3804 through 3838 both inclusive, abutting on Streets, all of which are described by metes and bounds on the attached plat. The street Right of Way contains 0.1154 Acres, leaving a net acreage in lots of 3.6744 Acres.
