Journal Entry.

This cause coming on to be heard by the court on the pleadings and the evidence adduced by the applicants, the court finds that the applicants are the sole owners of the following described portion of McKinstry & Parker's Highland Park Addition to the Village of Athens, Ohio, to-wit:-

Commencing at the Northeast corner of In-Lots No. 1485 in McKinstry and Parker's Highland Park Addition to the Village of Athens, Ohio; thence in a Westerly direction along the North line of Lots 1485 and 1502 to the Northwest corner of In-Lot No. 1502; thence in a Northerly direction to the Southwest corner of In-Lot No. 1503; thence North 50 degrees East to a point in the old road 20 feet from the Northwest corner of In-Lot No. 1513; thence in a Southeasterly direction, along said road to a point 20 feet from the Northeast corner of In-Lot No. 1493; thence in a Southerly direction to the Southeast corner of In-Lot No. 1493; thence in a Southerly direction to the Southeast corner of In-Lot No. 1486; thence in a Southerly direction to the place of beginning, and including a portion of Park Street, a 20 foot alley adjoining the old road, and Inlots Nos. 1486 to 1493 inclusive, and Nos. 1503 to 1513 inclusive.

That 30 days notice, by publication in the Athens Messenger has been given of the filing of their said petition, and that it is for the best interest of all concerned that said portion of said plat be vacated.

It is, therefore, ordered and decreed by the court that the above described portion of said Highland Park Addition to said Village of Athens, Ohio, be, and the same is, hereby vacated.

And said applicants are hereby ordered, within 30 days from the rising of this court, to file a copy of these proceedings, with the County Recorder of said Athens County; and are further ordered to pay the costs of these proceedings.
