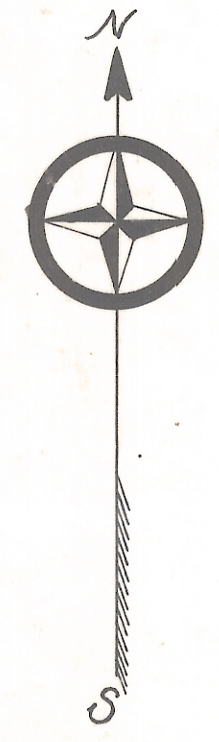


ENVELOPE: 232A

Lois C. Campbell's Addition to Coolville is situated in Outlot No. 20 in the village of Coolville and in the east side of fraction No. 32, town No. 5, range No. 11 and is numbered from 123 to 135 inclusive.

This plat is made to correct errors in what is known as Campbell's addition to Coolville which is recorded in Plat book No. 5 page 42 in the Recorder's office of Athens County Ohio and will make the same null and void.

Know all Men by these presents that I, Lois C. Campbell owner of the land delineated on this plat do hereby acknowledge the making of the same to be my voluntary act and deed and I hereby dedicate the streets shown thereon to public use forever.

An Ordinance to Approve and accept Lois C. Campbell's addition to Coolville O. Whereas, George K. Campbell laid out a subdivision of the village of Coolville into lots, a plat of which is recorded in plat book No. 5, page 42, in the recorder's office of Athens county Ohio; - and

Whereas, on said plat original lot number 104 was numbered 123, original lot number 99 was numbered 124, original lot number 100 was numbered 125, original lot number 101 was numbered 126, original lot number 102 was numbered 127, original lot number 103 was numbered 128; - and

Whereas, Lois C. Campbell, devisee under the last will and testament of said George K. Campbell, prepared another plat of said subdivision to correct said plat of said George K. Campbell, under the direction of S. H. Hibbard, County Surveyor, by Survey of June 14-1909, on which plat original lots numbers 104-99-100-101-102 and 103 have been given their their original numbers, and on which plat lot number 129 on said George K. Campbell's plat has been numbered 123, and lot number 130 on said George K. Campbell's plat has been numbered 124, and lot number 131 on said George K. Campbell's plat has been numbered 125, and lot number 132 on said George K. Campbell's plat has been numbered 126, and lot number 133 on said George K. Campbell's plat has been numbered 127, - and lot number 134 on said George K. Campbell's plat has been numbered 128, - and additional lots have been numbered on said plat of said Lois C. Campbell - as follows: numbers 129-130-131-132-133-134 and 135; now therefore

Be it Ordained by the Council of the village of Coolville:  
Sec. 1. That said plat of said Lois C. Campbell be hereby approved and accepted.  
Sec. 2. That this ordinance be in force and effect immediately upon its passage and legal publication.
