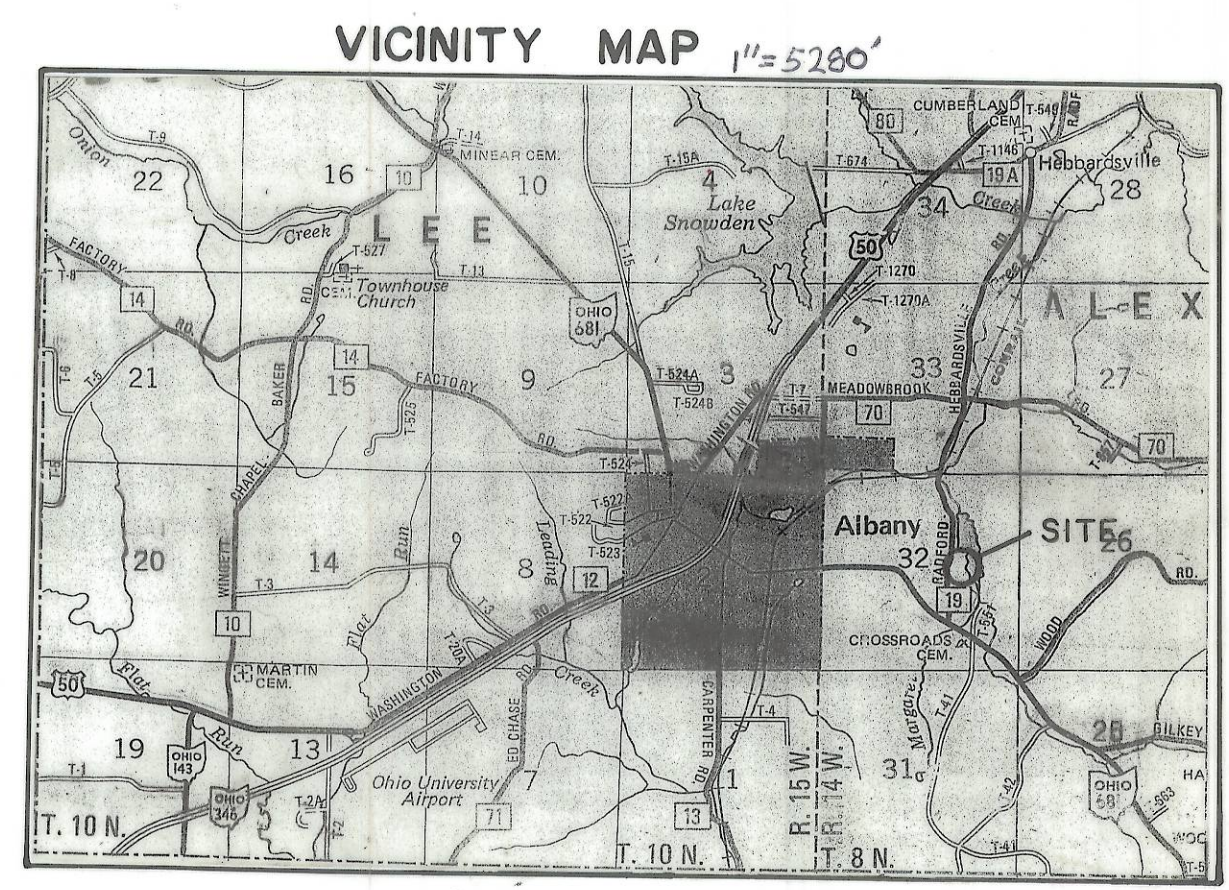


ENVELOPE: 54B
