

JOURNAL ENTRIES

This matter came on for hearing this 3rd day of November, 1965, on the petition of Dwight H. Rutherford, representing himself and other proprietors, for the alteration of a plat of Park Hill Subdivision in the City of Athens, Ohio, and on consideration of said petition and the evidence, the Court finds that thirty days' notice of the filing of said petition and the hearing thereof has been given by the applicant by publication in a newspaper printed and of general circulation in this County; that the Council of the City of Athens, Ohio by proper proceedings terminated in the passage and adoption of Ordinance Number 0-58-65 passed on the 20th day of September, 1965 approved the subject matter of this proceeding; that not less than two-thirds of the proprietors of the land or parts thereof described in said plat have joined in said application to alter said plat; and that no written or oral objection was made to said petition in open court or otherwise.

WHEREFORE, it is hereby ordered, adjudged and decreed that such plat be altered in the following respects:  
That Townsend Place Court, as it appears in Plat Book C, Page 33, Plat Records in the Athens County Recorder's Office and "Exhibit A" attached to the petition, be vacated and the boundaries of the lots of Park Hill Subdivision therein be redefined as shown on "Exhibit B" attached to the petition, to allow the development of larger lots resulting in the more advantageous public use of said land.
