

PETITION FOR ANNEXATION

TO THE COMMISSIONERS OF ATHENS COUNTY, STATE OF OHIO:

The Undersigned, being a majority of the adult freeholders residing in the following described territory, situated in the County of Athens, and adjacent to the City of Athens, to-wit:

Being in Lots 4, 6, 11, 12, 16, 34, 37, 38, 39, 40, 41, 42, 55, 56, 59 and 61 in Sections 1, 2, 7, 8, 9, 13, 14, and 15, Township 9, Range 14, Ohio Company Lands, Athens Township, Athens County, State of Ohio, and more particularly bounded and described as follows:

Beginning at a point on the northeast corner of a 33.35 acre tract of land now or formerly owned by Carlos R. & Thelma White, said point of beginning being the northeast corner of Lot 56, the northwest corner of Lot 38 and on the South line of Lot 57; thence with the south line of Lot 57 South 84° 59' East 267.27 feet to a point on the southeast corner of Lot 57, said point being the southwest corner of Lot 41 and the southwest corner of a 17.93 acre tract of land now or formerly owned by Nettie Jacobs; thence with the line between Lots 57 and 41 North 4° 21' East 629.73 feet to a point on said lot line, said point being the northwest corner of the Nettie Jacobs tract; thence with the North line of the Nettie Jacobs tract North 75° 46' East 436.99 feet to a point on said North line, said point being the southeast corner of a 16.89 acre tract of land owned by the State of Ohio; thence with the East line of said 16.89 acre tract North 4° 15' East 1692.61 feet to a point on the northeast corner of said 16.89 acre tract, said point being on the line between Lots 41 and 59; thence North 20° 28' West 718.34 feet to an iron pin, said iron pin being the southwest corner of Lowman's Addition; thence with the West line of Lowman's Addition North 27° 40' West 143.10 feet to an iron pin on said West line; thence continuing along the west line of Lowman's Addition North 22° 52' West 754.89 feet to a point in the center of Dairy Lane, passing an iron pin at 719.13 feet; thence with the center of said Lane South 77° 31' East 450.04 feet to a point in the center of said Lane; thence continuing along the center of said Lane North 78° 18' East 585.31 feet to a point in the center of Richland Avenue; thence with the center of Richland Avenue, along a 6° curve to the right an arc distance of 310.23 feet, having a radius of 955.37 feet, to the P.T. of said curve, said curve having a long chord distance of 308.86 feet and bearing north 12° 54' East; thence continuing along the center of Richland Avenue North 22° 12' East 312.70 feet to the P.C. of a 4° curve to the left; thence with said curve an arc distance of 325.00 feet, having a radius of 1432.39 feet, to the P.T. of said curve, said curve having a long chord distance of 324.29 feet and bearing North 15° 42' East; thence continuing along the center of Richland Avenue North 9° 12' East 1335.73 feet to the P.C. of a 4° curve to the right; thence with said curve an arc distance of 354.58 feet, having a radius of 1432.39 feet, to the P.T. of said curve, said curve having a long chord distance of 353.69 feet and bearing north 16° 17' East; thence continuing along the center of Richland Avenue, North 23° 23' East 414.57 feet to the point of intersection of the centerline of Richland Avenue and the center of Hocking River; thence with the center of Hocking River by the following courses and distances, South 38° 24' East 1077.37 feet and South 8° 18' East 798.46 feet and South 15° 47' East 804.69 feet and South 42° 50' East 434.91 feet to a point in the center of said river, said point being in the center of Coates Run extended; thence leaving said river and with the center of Coates Run South 53° 18' West 359.50 feet to a point; thence South 7° 28' East 182.47 feet to a point on the northwest corner of a 12.78 acre tract of land now or formerly owned by F. Dupler; thence South 45° 16' West 110.85 feet to the southwest corner of said 2.52 acre tract; thence north 37° 07' West 423.04 feet to a corner on the West line of said 2.52 acre tract; thence with the south line of a 4.7 acre tract of land now or formerly owned by Carrie Burson South 45° 13' West 336.06 feet to a point in the center of County Road 21; thence with the center of said County Road by the following courses and distance, North 64° 40' West 206.50 feet and North 51° 10' West 308.85 feet and North 31° 37' West 196.33 feet and North 20° 26' West 382.35 feet and North 10° 59' West 474.98 feet and north 19° 54' West 548.74 feet and North 22° 22' West 189.10 feet and North 0° 13' West 145.27 feet and North 24° 30' West 289.10 feet and north 43° 28' West 165.58 feet to a point in the center of said County Road No. 21; thence South 50° 09' West 933.30 feet to a southwest corner of Lot 37; thence continuing South 50° 09' West, along the line between Lots 35 and 55, 1694.31 feet to a point; thence North 26° 13' West 205.73 feet to the center of a County Road; thence North 63° 27' West 467.23 feet to a point; thence North 24° 20' West 1430.88 feet to a point, passing the center line of U.S. Route 50 at 663.00 feet; thence North 59° 08' East 167.33 feet to the center of aforesaid County Road; thence with the center of said road by the following courses and distances, North 16° 08' West 185.75 feet and North 28° 07' West 186.64 feet and North 6° 18' West 767.15 feet and North 42° 15' West 362.89 feet and south 83° 23' West 202.18 feet and North 72° 37' West 202.24 feet and North 51° 22' West 213.11 feet to a point in the center of said road, said point being the Southwest corner of a 33.35 acre tract of land now or formerly owned by Carlos R. & Thelma White; thence North 33° 49' East 896.51 feet to the northwest corner of said 33.35 acre tract; said northwest corner being on the line between Lots 56 and 57; thence with said Lot line South 85° 30' East 1403.92 feet to the point of beginning.
