BOUNDARY SURVEY DESCRIPTION**

Situated in the State of Ohio, County of Athens, Township of Trimble, and being a part of Section 7, Town, 11 N, Range 14W and being more particularly described as follows:

**BEGINNING**, at an iron pin set in the Easterly right of way of the Norfolk - Southern Railroad (66.00' r/w),

Thence, from said point of beginning along the Easterly right of way of the railroad with a curve to the left having a Radius of 932.78 feet, a Delta Angle of 17° 59' 57" and a Chord Bearing S 30° 12' 38" W at a distance of 291.82 feet to an iron pin set;

Thence, continuing along said Easterly right of way line S 21° 12' 55" W 862.70 feet to an iron pin set;

Thence, leaving the Easterly right of way of the railroad N 89° 34' 48" W 35.30 feet to an iron pin set in the centerline of said railroad;

Thence, with the centerline of said railroad S 21° 12' 55" W 1415.05 feet to a point on the East bank of Sunday Creek;

Thence, the following Eight (8) courses and distance are along the Easterly bank of the Sunday Creek and are to iron pins set:

- 1) N 1° 44' 57" W 297.27 feet;
- 2) N 02° 35' 54" E 336.98 feet;
- 3) N 01° 58' 35" W 463.22 feet;
- 4) N 13° 39' 12" W 308.79 feet;
- 5) N 03° 22' 15" W 531.76 feet;
- 6) N 04° 37' 36" E 252.62 feet;
- 7) N 08° 02' 56" E 184.30 feet;
- 8) N 14° 34' 51" E 86.85 feet;

Thence, N 34° 53' 13" E 169.56 feet to a point in the centerline of Sunday Creek;

Thence, the following Six (6) courses and distances are to points in the centerline of Sunday Creek and follow the Southern Corporation line of the Village of Jacksonville:

- 1) S 88° 38' 03" E 257.28 feet;
- 2) S 83° 45' 04" E 376.14 feet;
- 3) S 87° 33' 36" E 212.21 feet;
- 4) S 81° 47' 35" E 280.74 feet;
- 5) S 78° 28' 15" E 190.43 feet;
- 6) S 69° 22' 12" E 204.26 feet;

Thence, continuing in said centerline and following said corporation line S 84° 29' 06" E 199.83 feet to a point on the Easterly right of way of the Norfolk-Southern Railroad;

Thence, along the Easterly right of way of said railroad S 77° 14' 39" W 106.71 feet to an iron pin set;

Thence, continuing along said railroad with a curve to the left having a Radius of 932.78 feet, a Delta Angle of 43° 18' 23" and a Chord Bearing S 60° 51' 48" W at a distance of 686.37 feet to the PLACE OF BEGINNING.

Said Lot 1 as surveyed contains 48.627 acres or 2,118,172 square feet more or less. Subject to the right of way of the Norfolk - Southern Railroad right of way and all legal easements public or private of record.

Bearings of this description are based on the centering of the Norfolk - Southern Railroad as being S 21° 12' 55" W and are used to denote angles only.

**PROPOSED PRIVATE,  
TEMPORARY ACCESS EASEMENT**

Being a 30.00 foot wide strip of land, 15.00 feet on each side of the centerline which is described as follows:

Beginning at a point in the centerline of Jacksonville road, said point being S 00° 34' 36" E a distance of 15.00 feet from the Northeast corner of Pin Oak Estates Subdivision, Plat Cabinet Slide 489B, Recorder's Office, Athens County, Ohio;

Thence across Pin Oak Estates Subdivision the following three (3) bearings and distances:

- S 89° 46' 38" W 185.39 feet to a point;
- N 87° 12' 31" W 351.25 feet to a point;
- S 87° 39' 47" W 777.41 feet to a point in the Easterly right of way of the Norfolk-Southern Railroad, said point being the Point of Terminus, containing 0.805 acres, more or less, and subject to all rights of way, easements, and restrictions of record.

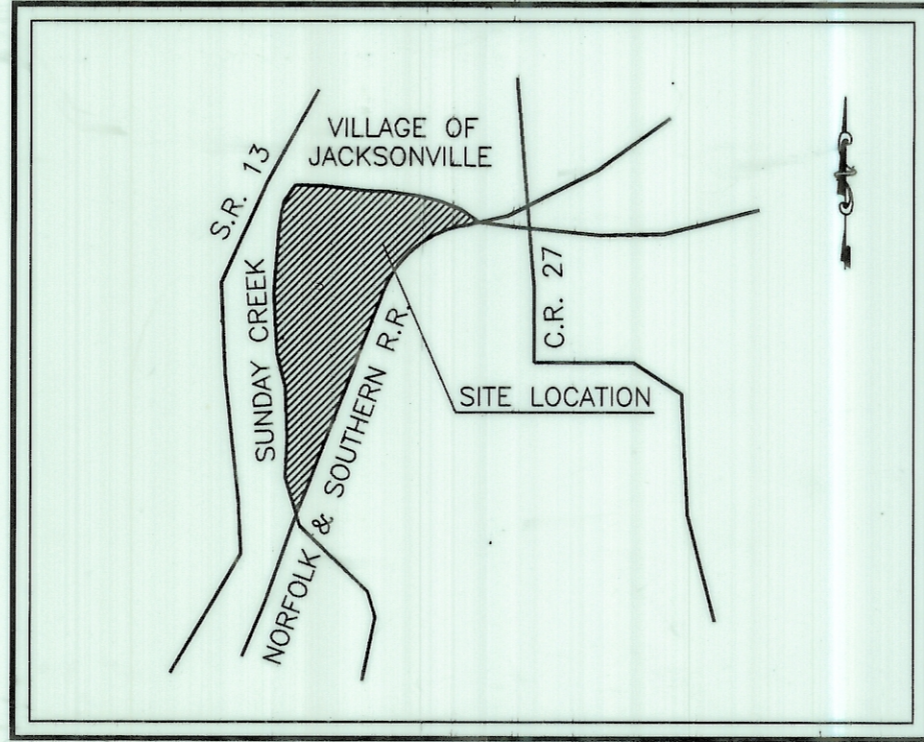
