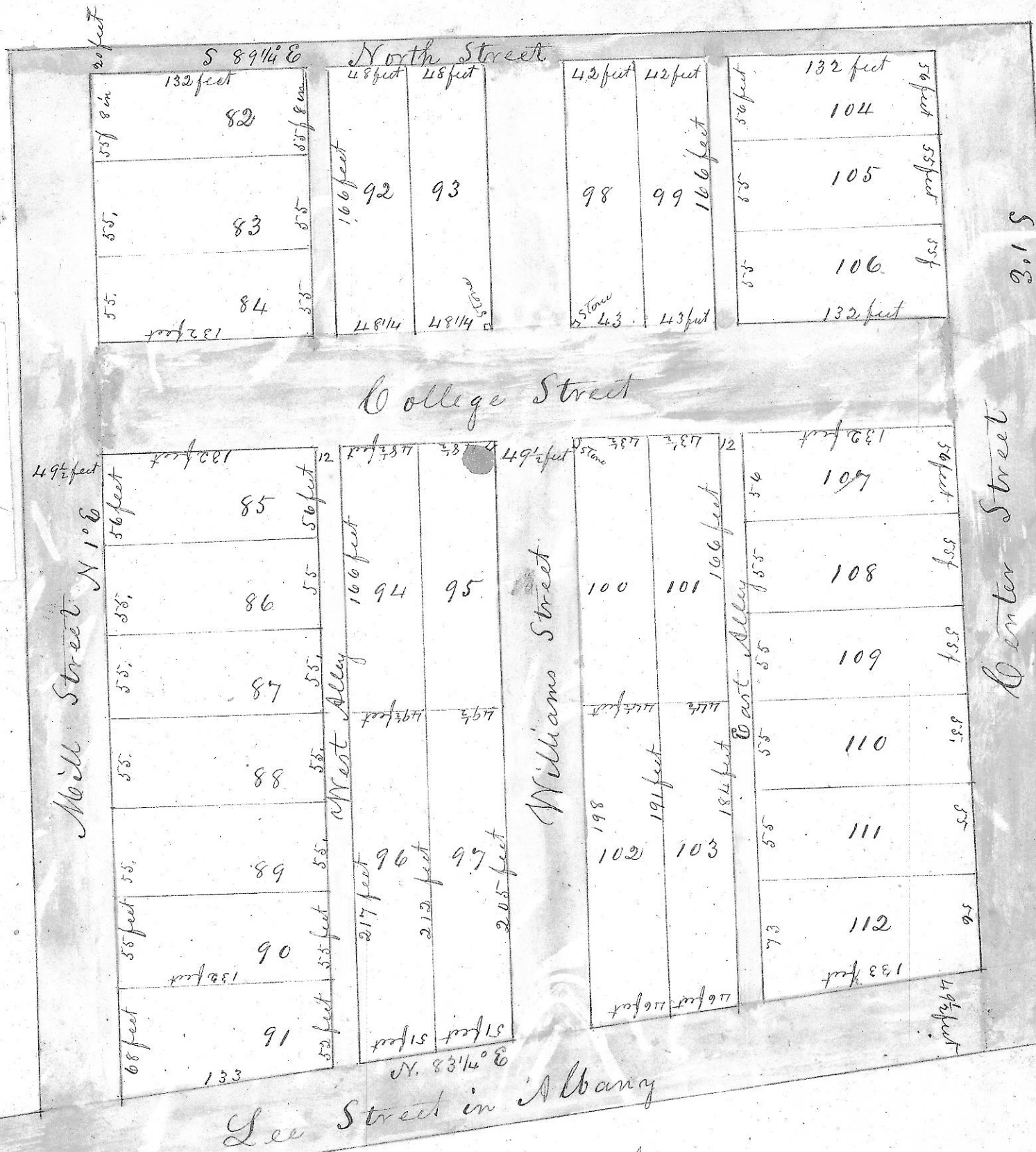

Albany

The above Plat represents a survey of an Addition to the Town of Albany in Athens Co. Ohio. Mill, Williams and Center Streets each 75 links wide, College Street is 100 links wide, North Street is 33 links wide, East and West Alleys 12 feet wide. Lots No 82, 83, 84, 86, 87, 88, 89, 90, 105, 106, 108, 109, 110, 111, are each 132 feet long and fifty five feet wide and Lots No 85, 104, 107, are each one hundred and thirty two feet long (132) and fifty six feet (56) wide, and Lots No 92 & 93 each one hundred and sixty six feet long (166) & 48 & 48 1/2 feet wide and Lots No 98 & 99 each one hundred and sixty six feet (166) long & forty two by forty three (42 by 43) feet wide, and Lots No 94 & 95 each one hundred and sixty six feet long & 48 1/2 by 49 1/2 feet wide and Lots No 100 & 101 each 146 feet long & 44 1/2 by 44 1/2 feet wide, and Lot No 96 217 feet on West side & 212 on the east side long and 49 1/2 feet at the North end, and 57 feet at the South end and Lot 97, is 212, w side & 205 E. side feet long and 49 1/2 feet at the N. end and 57 feet at the South end wide and Lot 102 is 198 feet on W side & 191 feet on the East side long and 44 1/2 feet at the N. end & 46 feet at the S. end wide and Lot 103 is 191 feet w side & 184 E. side long & 44 1/2 feet N. end & 46 feet at S. end wide, and Lot 112 is 133 feet side & 132 feet N side long & 73 feet N end & 52 feet E. end wide, and Lot 91 is 133 feet S. side & 132 N. side long & 68 w. end & 52, E. end wide. A Stone is set at the North East corner of Lot 95, marked 1852, and another stone at S.W. corner of Lot 98, marked with a cross.
