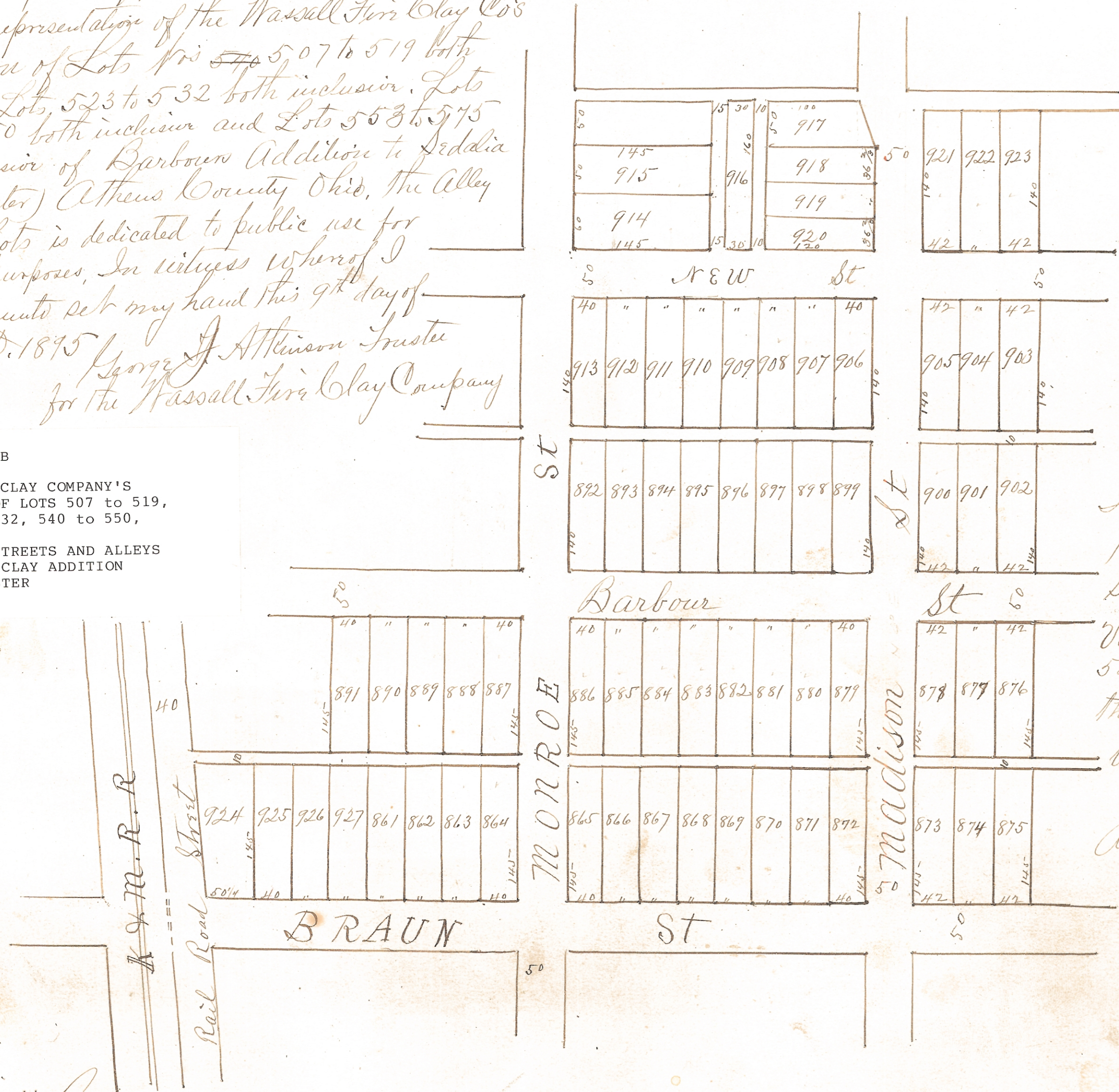


The Wassall Fire Clay Co's Subdivision of Certain Lots in Barbour's Addition

Whereas a petition signed by George J. Atkinson Trustee  
 for the Wassall Fire Clay Co, owner of lots abutting on the  
 Street and alleys hereinafter mentioned and described, has been  
 presented to the Council of the Incorporated Village of  
 Athens County, Ohio, praying for the vacation of the same, and  
 Whereas notice of the pendency and prayer of such petition has  
 been given by publishing the same in the Valley Gazette  
 a newspaper of general circulation in the said incorporated  
 village for six consecutive weeks ending on the 4th day of  
 April 1895; and Whereas said Council is satisfied that  
 there is good cause for such vacation, that it will not be  
 detrimental to the general interest, and that the same should  
 be made, Therefore, be it ordained by the Council of the  
 Incorporated Village of Gloucester, Athens County, Ohio,  
 that a strip twenty feet wide off of that portion of Madison  
 Street lying within Barbour and Braun's Addition to said  
 Village, also that portion of an alley lying east of lot numbers  
 546, 547, 548 and 549, in said Addition to said Village, also  
 the alley on the East boundary of said Addition to said Village,  
 be and the same are hereby vacated. Passed April 16th 1895
