Situated in the Township of Athens, County of Athens and State of Ohio, and in Farm Lot 16, Section 2, Town 9, Range 14, bounded and described as follows, to-wit: Beginning at an iron pin at the southeast corner of Farm Lot 16; thence along the south line of Farm Lot 16 north 84° 17' 55" west 600.00 feet to an iron pin; thence north 5° 16' 49" east 656.97 feet to an iron pin; thence south 83° 28' 32" east 600.00 feet to an iron pin; thence south 5° 16' west 669.55 feet to the place of beginning, containing 9.132 acres, more or less.

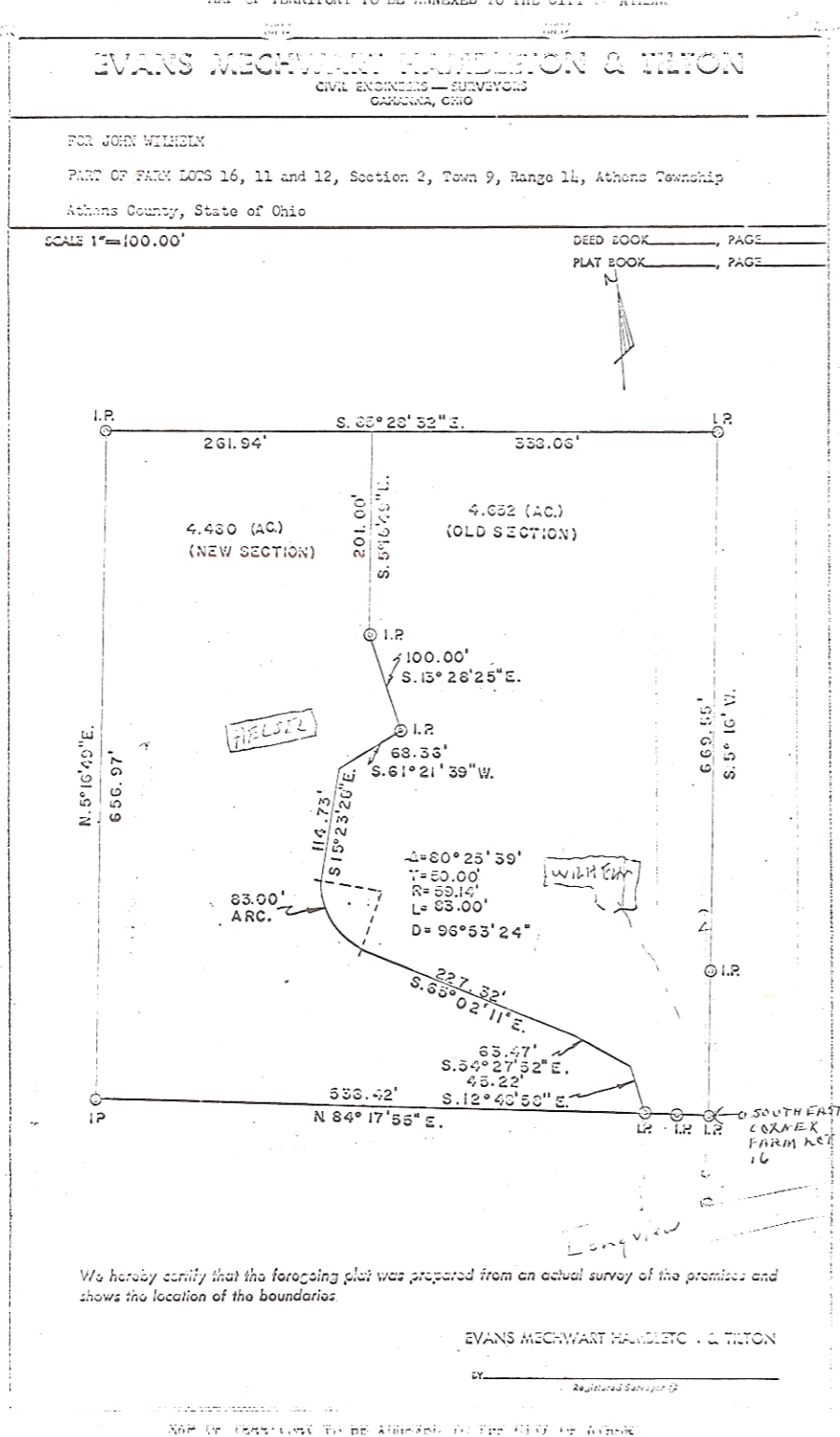

Mr. Cline offered the following Resolution and moved its adoption: WHEREAS a petition and description as recorded above for the annexation of certain territory to the City of Athens has been filed this day with the Board of Athens County Commissioners by John R. Wilhelm, as Agent of the petitioners.

THEREFORE BE IT RESOLVED that the said petition and plat be approved by the Board of County Commissioners, and that the time of hearing be set for July 16, 1970 at 10:00 A.M. D.S.T. in the Office of the Board of County Commissioners, Court House, Athens, Ohio, and; FURTHER BE IT RESOLVED that the Clerk of this Board be authorized to file said petition and plat of the proposed territory, with a copy of the Resolution of the Board of County Commissioners with the City Auditor of Athens, as provided in Section 709.03 of the Revised Code of the State of Ohio. Mr. Edwards seconded the Resolution. The roll being called upon its adoption the vote resulted as follows: Mr. Cline, yes; Mr. Edwards, yes; Mr. White, yes.

Ordinance No. C-49-70 Passed SEPTEMBER 24, 1970

AN ORDINANCE ACCEPTING THE APPLICATION FOR ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF ATHENS, OHIO.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATHENS, OHIO:

Section I: That the application of John R. Wilhelm, Margaret M. Wilhelm, husband and wife, and Robert G. Hiesel and Elsie D. Hiesel, husband and wife, for the annexation of the following described territory in the County of Athens and adjacent to the City of Athens, to-wit:

Situated in the township of Athens, county of Athens, and state of Ohio, and in farm lot 16, Section 2, town 9, range 14, bounded and described as follows, to-wit: Beginning at an iron pin at the southeast corner of farm lot 16; thence along the south line of farm lot 16 north 84 degrees 17 minutes 55 seconds west 600.00 feet to an iron pin; thence north 5 degrees 16 minutes 49 seconds east 656.97 feet to an iron pin; thence south 83 degrees 28 minutes 32 seconds east 600 feet to an iron pin; thence south 5 degrees 16 minutes west 669.55 feet to the place of beginning, containing 9.132 acres, more or less.

And the accurate map of the above described territory, together with the petition for its annexation and other papers relating thereto, and a certified transcript of the proceedings of the County Commissioners in relation thereto now on file with the Clerk of this Council are hereby accepted.

Section II: This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

Re: Petition of John R. Wilhelm, et al for Annexation of Territory Situated in the Township of Athens to the City of Athens, Athens County

This day this matter came on to be heard on the Petition of John R. Wilhelm and others filed herein on April 30th, 1970, to obtain the annexation of the territory in the Petition described to the City of Athens, Athens County, and being fully advised in the premises, find:

- (1) that the Petition contains all matter required in Sec. 709.02, Revised Code; (2) that notice of this proceeding has been given and published as required by Sections 709.03 and 709.031, Revised Code; (3) that the persons whose names are subscribed to the Petition are all the adult freeholders residing in the territory and therefore, as of the time that the Petition was filed herein, the number of valid signatures on the Petition constituted a majority of the adult freeholders residing in the territory proposed to be annexed; (4) that the territory sought to be annexed is adjacent to the City of Athens; (5) that the Petition contains all matter required by law and that the statements therein contained are true; (6) that the territory described in the Petition is not unreasonable large, the map or plat thereof is accurate, the general good of the territory sought to be annexed will be served if the Petition is granted, and that it is right and proper that the Petition be granted.

WHEREUPON, it is ordered that the prayer of the Petition be granted and the territory described therein may be annexed to the City of Athens in accordance with law and that a certified transcript of all orders of this Board including the Petition, map, and all other papers on file relating to the annexation proceedings be delivered to the Auditor of the City of Athens.
