Commencing at a 5/8" o.d. iron pin found marking the Southeast corner of Lot 13 of Gilkey Subdivision conveyed to Roger P. & Carol J. Smith, as recorded in O.R. Book 344, Page 359, also being the Northeast corner of said parcel conveyed to Hendrix (OR592,Pg480), of which this description is a part, being on the West line of a 0.53 Acre parcel conveyed to William R.

Butterworth, Jr. & April Ann Butterworth, as recorded in O.R. Book 471, Page 1428, said parcel conveyed to Butterworth (OR471,Pg1428);

Thence, S 04°39'19" W 106.80 feet with the East line of said parcel conveyed to Hendrix (OR582,Pg480), of which this description is a part, also being the West line of said parcel conveyed to Butterworth (OR471, Pg1428), to an iron pin set, and being the **PRINCIPLE PLACE OF BEGINNING**, of the 0.243 Acre parcel herein to be described;

Thence, S 04°39'19" W 106.80 feet continuing with the East line of said parcel conveyed to Hendrix (OR582,Pg480), of which this description is a part, also being the West line of said parcel conveyed to Butterworth (OR471, Pg1428), to a 5/8" o.d. iron pin found w/cap stamped "ODOT" on the North Right of Way Line of State Route 681 marking Station 401+74.36/35.00' Left of a centerline survey of State Route 681, as shown on Plan No. ATH-681-7.30-7.64, on file at the Ohio Department of Transportation District 10 Office, Marietta Ohio, and being the Southeast corner of said parcel conveyed to Hendrix, of which this description is a part;

Thence with the North Right of Way Line of State Route 681, with the following two (2) courses and distances:

- 1) S 88°12'19" W 84.51 feet to a 5/8" o.d. iron pin found w/cap stamped "ODOT" marking Station 400+90.00/40.00' Left;
- 2) N 44°28'32" W 19.38 feet to a 5/8" iron pin found w/cap stamped "ODOT" on the East Right of Way Line of Louisa Avenue (40' Wide R/W), and being Station 400+77.73/55.00' Left;

Thence, N 04°39'19" E 96.47 feet with the East Right of Way Line of Louisa Avenue, to an iron pin set;

Thence, S 89°29'17" E 98.89 feet leaving Louisa Avenue with a line across said parcel conveyed to Hendrix (OR592,Pg480), of which this description is a part, to the **PRINCIPLE PLACE OF BEGINNING**, and containing **0.243 Acres**, more or less, and is subject to all legal easements, right of ways, restrictions, and zoning ordinances of record.

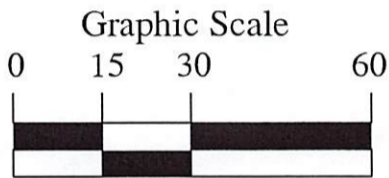

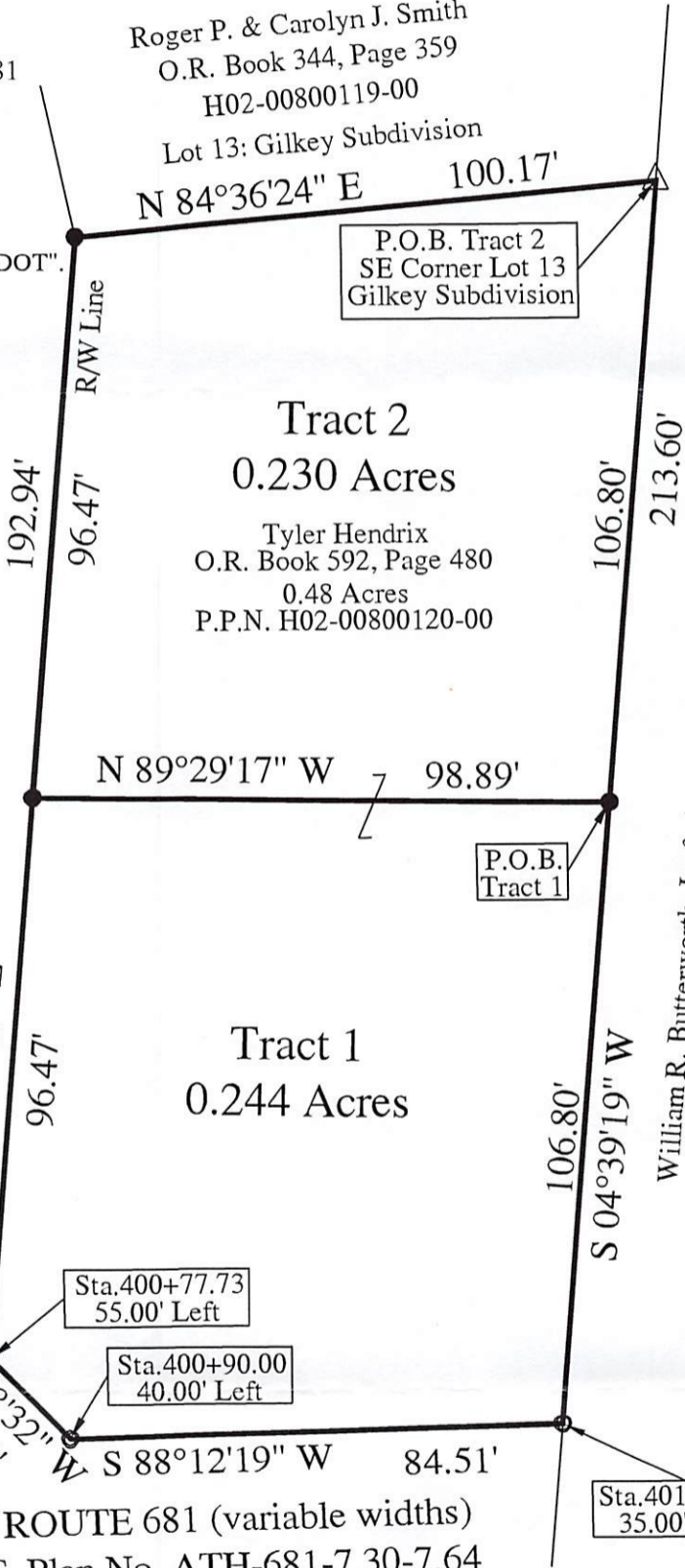
