Being a Survey of 2 parcels conveyed to Idyllic Acres, Ltd., as recorded in O.R. Book 361, Page 516, in the Athens County Deed Records, and being all of Auditor's P.P.N. H02-00100029-00 & P.P.N. H02-00100030-00, and P.P.N. H01-00100005-06, and further described as follows;

Commencing at a railroad spike found in Carpenter Road marking the Southeast corner of the Southwest Quarter of Section 2, also being the Northeast Corner of the Northwest Quarter of Section 1, and being the PRINCIPLE
PLACE OF BEGINNING of the 51.144 Acre parcel herein to be described;

Thence, S 04°02'47" W 198.96 feet with the East line of the Northeast Quarter of Section 1 and said 0.918 Acre parcel of which this description is a part, to a point marking the Northeast corner of a 45.166 Acre parcel conveyed to William A. Krusling & Marla A.Chiodi, as recorded in O.R. Book 544, Page 2530;

Thence leaving Carpenter Road with the boundary of said 0.918 Acre parcel conveyed to Krusling & Chiodi, with the following two (2) courses and distances:

- 1) N 86°44'09" W 200.14 feet to an iron pin set, and passing over an iron pin set at 30.00 feet;
- 2) N 03°58'37" E 198.92 feet to an iron pin set on the North line of Section 1 of Lee Township, also being the South line of Section 2 and the Corporation Line of the Village of Albany;

Thence, N 86°44'48" W 1165.50 feet with the North line of Section 1 of Lee Township and said parcel conveyed to Krusling & Chiodi, also being the South Corporation Line of the Village of Albany and Section 2, to a 5/8" o.d. iron pin found (no cap) marking the Southeast corner of a 68.65 Acre parcel conveyed to Janet Sayers, as recorded in O.R. Thence, S 86°51'59" E 696.59 feet with the South line of said parcel conveyed to Shank-Drumm, and extending along the South line of a parcel conveyed to John Robert & Angela Dawn Gibson, as recorded in Deed Volume 216, Page 443, and extending along the South line of a parcel conveyed to Michael & Malinda Mowry, as recorded in O.R. Book 458, Page 2503, and extending to an iron pin set on the South line of a parcel conveyed to Madison L. Sprankle, as recorded in O.R.
