Situated in Lease Lot Number 2, Section 26 and Lease Lot Number 4, Section 32, Town 8, Range 14, Alexander Township, Athens County, Ohio and described as follows:

Commencing at the northeast corner of said Lease Lot Number 4; thence along the west property line of a 5.28 acre tract described in Volume 326 Page 77 of the Athens County Deed Records on an assumed bearing South 14 degrees 39 minutes 23 seconds West a deed distance of 211.40 feet to a found iron pin; thence continuing along said west property line 271.95 feet to a found iron pipe THE TRUE POINT OF BEGINNING; thence along the south property line of said 5.28 acre tract South 66 degrees 37 minutes 07 seconds East 374.12 feet to a point (witness a fence post North 06 degrees 28 minutes 30 seconds West 0.76 feet and a found iron pin North 11 degrees 36 minutes 01 seconds East 179.40 feet); thence along the west property line of a 6.041 acre tract described in Volume 339 Page 57 of the Athens County Deed Records South 11 degrees 36 minutes O1 seconds West 131.13 feet to a point (witness a fence post North 82 degrees 10 minutes 49 seconds West 0.54 feet); thence North 84 degrees 11 minutes 45 seconds West 122.95 feet to a set iron pin; thence North 83 degrees 18 minutes 43 seconds West 121.10 feet to a set iron pin; thence South 62 degrees 26 minutes 35 seconds West (passing a set iron pin at 140.52 feet for a total distance of 172.96 feet to a set railroad spike in the center of State Route 681; thence along said Route North 42 degrees 20 minutes 0' seconds West 124.94 feet to a set railroad spike in the center of said Route; thence leaving said Route North 34 degrees 24 minutes 37 seconds East (passing set iron pins at 35.02 feet and 166.37 feet) for a total distance of 288.52 feet to the point of beginning containing 2.1402 acre of which 1.2415 acre is in Lease Lot Number 4 and 0.8987 acre is in Lease Lot Number 2 and being part of a 24.63 acre remainder tract recorded by Volume 237 Page 519 and Volume 354 Page 545 of the Athens County Deed Records.

Note: All set iron pins are capped 5/8 inch in diameter and 31 inches in length.
