

9.412 Acres

Situate Ohio Company Purchase, Town 8, Range 14, Lease Lot 2, Alexander Township Section 15, Athens County, Ohio.

Being deeded to William L. Green and Marian E. Green, Official Record Book 301, pages 391-393, and known as parcel B010010046700 as the parent parcel and tract.

Commencing at a point at the northeast corner of said Lease Lot 2 of Section 15 of Alexander Township; Thence S03°40'16"W 297.50 feet to a point in Fisher Road, County Rd. 17, and being the point of beginning of the tract herein described;

- 1.) Thence S03°40'16"W 863.48 feet along a common boundary to Pratt 466-1480 and Haning 246-334, to a ¾-inch diameter pipe found at the base of a fence post, passing an iron pin capped Swoyer at 21.35 feet and passing a ¾-inch diameter pipe found at 221.69 feet;
- 2.) Thence N85°45'28"W 654.95 feet along a common boundary to Baker 455-502 to a point in Wood Road, County Rd. 15, passing ¾-inch diameter pipes found at 436.08 feet and at 634.95 feet;
- 3.) Thence N08°27'35"W 168.61 feet to a point in County Rd. 15;
- 4.) Thence S85°45'08"E 254.27 feet over the lands of the parent tract to an iron pin set, passing an iron pin set at 30.00 feet;
- 5.) Thence N03°40'40"E 662.08 feet to a point in Fisher Road, County Rd. 17, passing iron pins set at 462.08 feet, and at 622.08 feet;
- 6.) Thence N89°01'15"E 31.20 feet to a point in County Rd. 17;
- 7.) Thence N87°04'00"E 307.46 feet to a point in County Rd. 17;
- 8.) Thence S83°16'35"E 99.64 feet to the point of beginning containing a total of 9.412 acres and being a portion of said parent tract and parcel.

Said 9.412 Acre Tract shall reserve the right to repair or replace an existing below surface water line from Le-Ax main water line on County Rd. 15 to the tap or meter on the east side of County Rd. 15 and continuing in an easterly direction to supply the house of said 9.412 acres. Said right to repair or replace includes the right to dig, but also the responsibility to leave the surface as before, and to do so in a timely manner. Further it is understood that no structures or devices shall be constructed over or on said water line.

Subject to all other easements, rights-of-way, covenants and agreements of record.

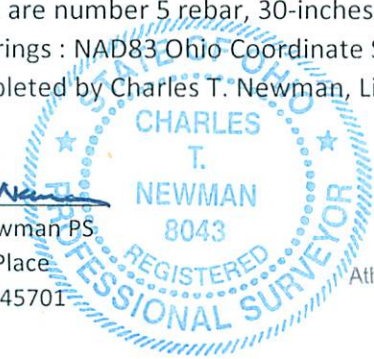

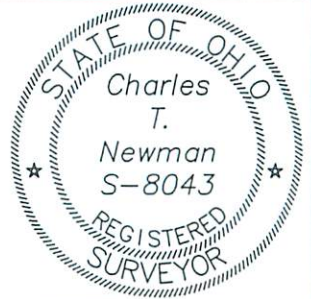

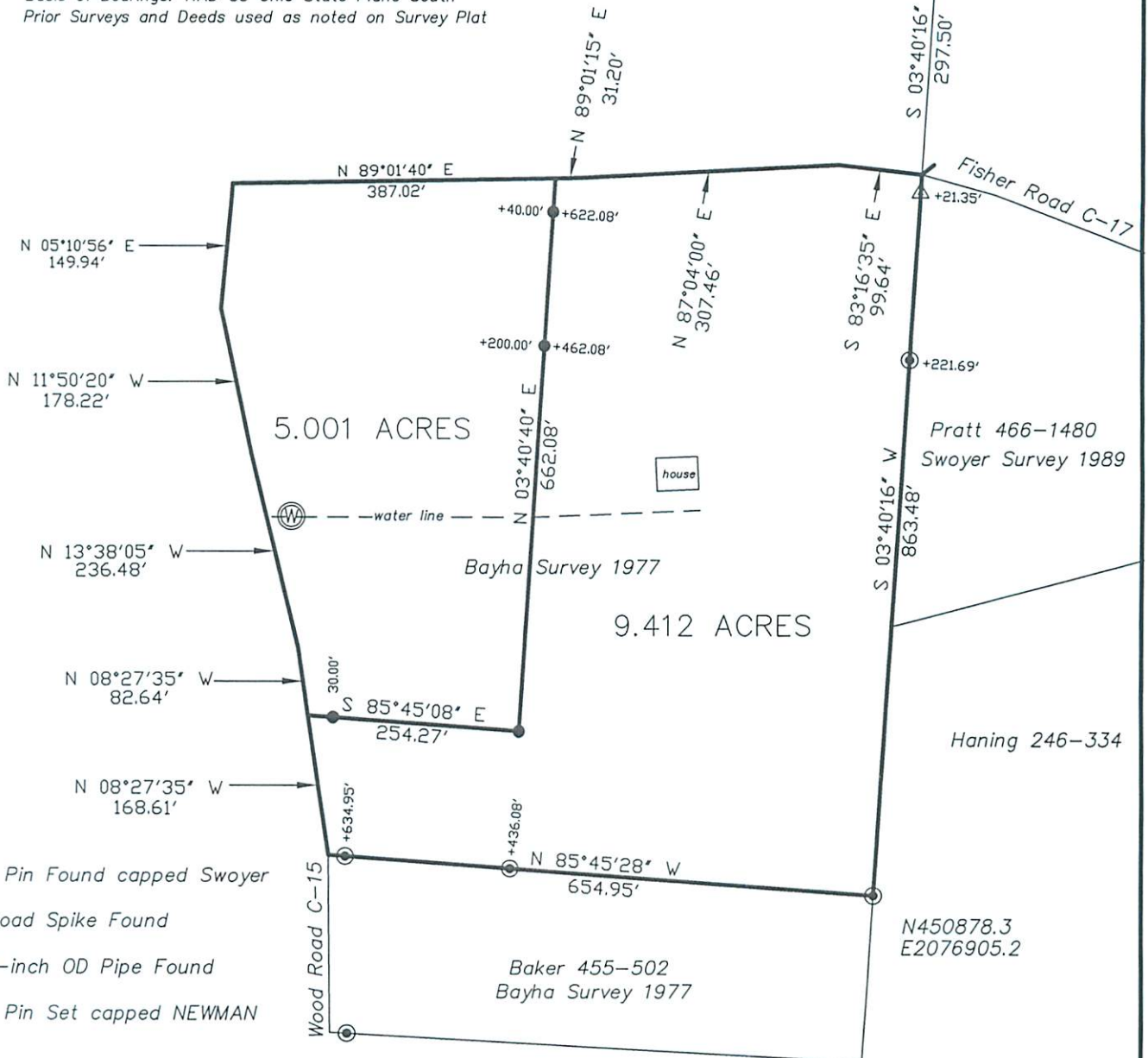
