BOUNDARY DESCRIPTION OF 5.01 ACRES

Situated in Farm Lot 3 of Section 2, Town 8, Range 14, Alexander Township, Athens County, Ohio and described as follows:

Commencing at a stone (calculated location) at the northwest corner of Farm Lot 1 of said Section 2; thence on an assumed bearing of North 2 degrees 14 minutes 46 seconds East, a distance of 338.50 feet to a point on the south line of a 23.19 acre tract described in Volume 151 Page 862 of the Athens County Official Records; thence along the south line of said 23.19 acre tract North 87 degrees 45 minutes 13 seconds East, a distance of 221.12 feet to a found iron pin; thence on an arbitrary line North 88 degrees 25 minutes 05 seconds East, a distance of 37.72 feet to a point in the center of Athens County Road 89 THE TRUE POINT OF BEGINNING; thence along the east line of said 23.19 acre tract and the center of said Athens County Road 89 North 49 degrees 43 minutes 29 seconds West, a distance of 73.48 feet to a point; thence leaving the east line of said 23.19 acre tract and the center of Athens County Road 89 North 87 degrees 23 minutes 52 seconds East (passing a set iron pin at 29.97 feet) for a total distance of 418.70 feet to a set iron pin; thence North 9 degrees 21 minutes 18 seconds West, a distance of 325.35 feet to a set 1 1/4" galvanized pipe; thence North 87 degrees 23 minutes 52 seconds East, a distance of 555.77 feet to a set 1 1/4" galvanized pipe on the east line of a 20.67 acre tract described in Volume 170 Page 650 of the Athens County Official Records; thence along a boundary agreement line between the grantor and William S. Cooley, owner of a 30.00 acre tract described in Volume 227 Page 405 of the Athens County Deed Records, South 1 degrees 59 minutes 28 seconds East (passing a set 1 1/4" galvanized pipe at 371.74 feet) for a total distance of 373.12 feet to a railroad tie fence corner; thence along a boundary agreement line between the aforesaid property owners South 87 degrees 23 minutes 52 seconds West (passing a railroad tie set vertically in a fence line at 843.75 feet, and a set iron pin at 848.12 feet) for a total distance of 878.39 feet to the point of beginning and containing 5.0071 acres, and being a part of a 20.67 acre tract described in Volume 170 Page 650 of the Athens County Official Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer P.S. 6765. The above
