DESCRIPTION OF A 0.011 ACRE PARCEL

Situated in Alexander Township, Athens County, State of Ohio

Being a **0.011 acre** parcel of land located in Section 30, Lease Lot 1, Township 8 North, Range 14 West, Ohio Company Purchase, Alexander Township, Athens County, State of Ohio, and being part of a 0.31 acre parcel as conveyed to Richard E. Cone II & Linda L. Cone by a deed recorded in Deed Book 218 at Page 231 of said county deed records, and being more fully described as follows:

Beginning at an iron pin set at the northeasterly corner of said 0.011 acre tract, from which the calculated southeast corner of Section 30 bears S 25° 55' 28" E, 1530.29 feet for reference;

Course No. 1: Thence, with a new division line through said 0.31 acre parcel, S 13° 14' 03" W, passing an iron pin set at 11.97 feet for reference, a total distance of 12.91 feet, being a point on the northerly line of an existing 50 foot width right of way;

Course No. 2: Thence, with the northerly line of said right of way, N 82° 14' 59" W, 31.93 feet to a point;

With a new division line through said 0.31 acre parcel the following two courses:

Course No. 3: Thence, N 13° 22' 19" E, passing an iron pin set at 0.83 feet for reference, a total distance of 15.97 feet to an iron pin set;

Course No. 4: Thence, S 76° 44' 41" E, 31.75 feet to the **Point of Beginning**, containing **0.011 acres**, more or less, and being subject to all legal rights of way and easements of record.

Bearings, coordinates and distances are based on Ohio State Plane (South Zone) Grid, NAD83 (CORS 2011) datum.

Plat of survey is attached hereto and made a part thereof.

All iron pins set being 5/8" x 30" rebar with plastic cap stamped "Buckley Group - 04153".

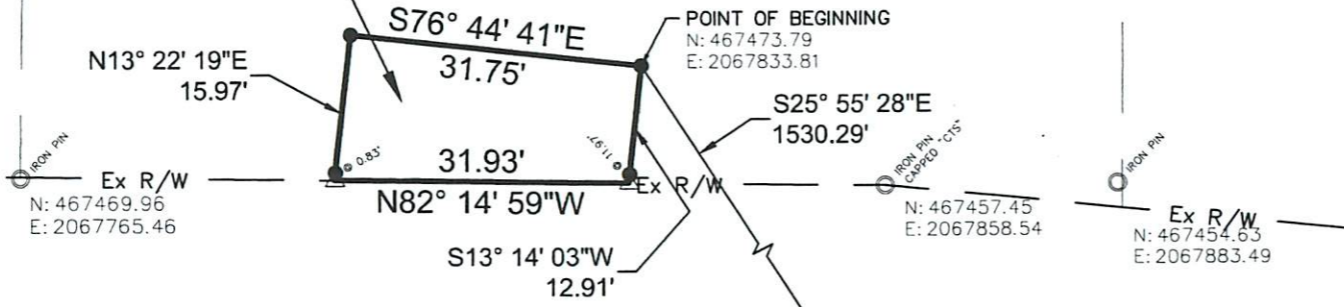

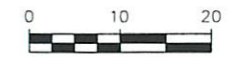
