DESCRIPTION OF A 5.80 ACRE TRACT

Situated in Section 15, T.8, R.14, Alexander Township, Athens County, Ohio and being more particularly described as follows:

Commencing at the South-east corner of Farm-lot #1, thence, North 19 chains (deed) to a point; thence, West, 19.89 chains (deed) to an iron pin found at the South-east corner of a 3.07 acre tract; thence, along the South-line of said tract West, 818.40 feet to a point in County Road 15; thence, along said road, South 11 Degrees 46 Minutes West, 33.19 feet to the point of beginning for the tract of land herein described:

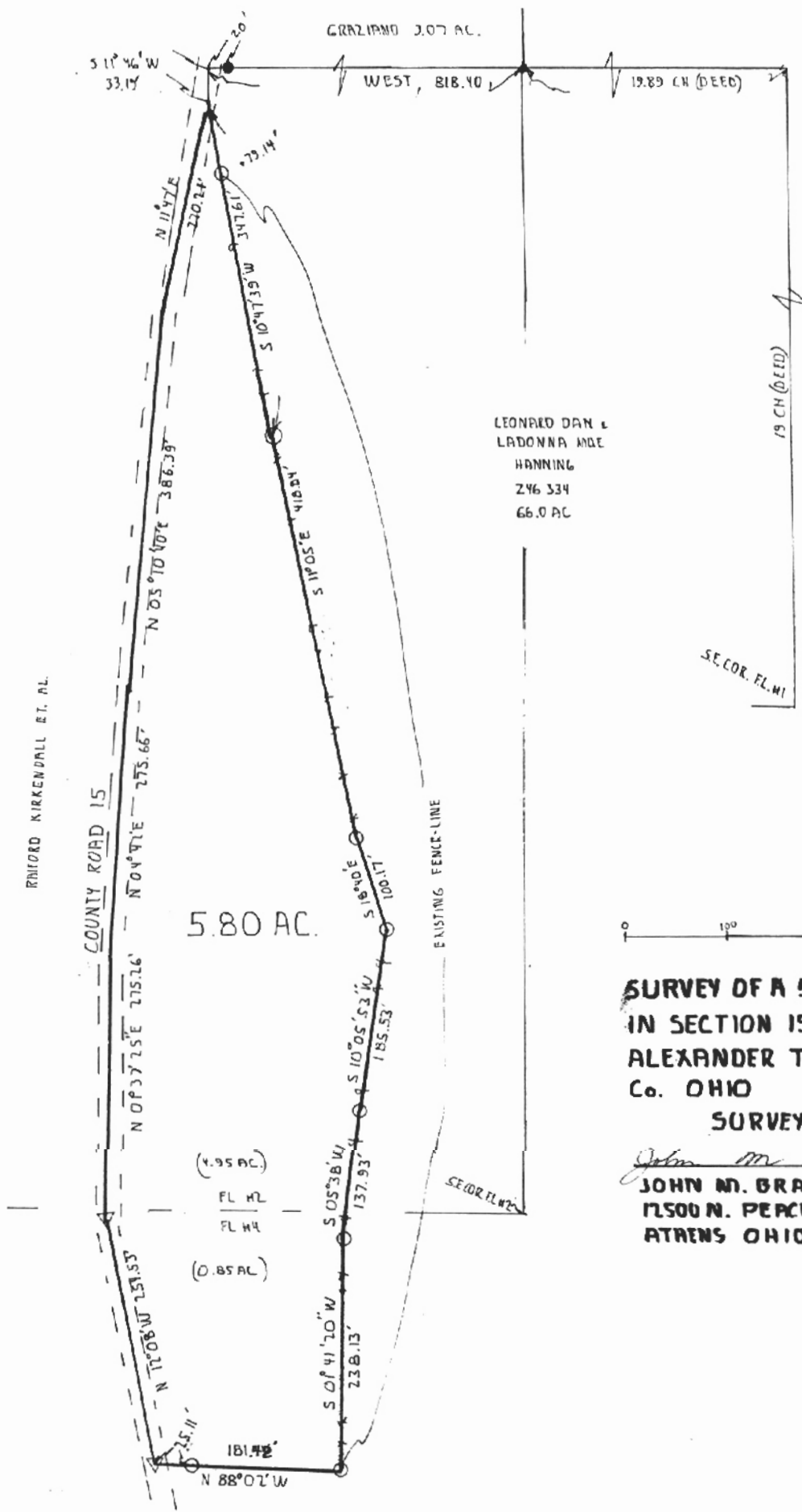
Thence, along an existing fence-line, South 10 Degrees 47 Minutes 39 Seconds East, 347.61 feet to an iron pin set; thence, South 11 Degrees 05 Minutes East, 418.84 feet to an iron pin set; thence, South 18 Degrees 40 Minutes East, 100.17 feet to an iron pin set; thence, South 10 Degrees 05 Minutes 53 Seconds West, 185.53 feet to an iron pin set; thence, South 05 Degrees 38 Minutes West, 137.93 feet to an iron pin set; thence, South 01 Degrees 41 Minutes 20 Seconds West, 238.13 feet to an iron pin set; thence, leaving said fence-line North 88 Degrees 02 Minutes West, 181.42 feet to a P.K. nail set in County Road #15; thence, along said road, North 12 Degrees 08 Minutes West, 254.53 feet to a P.K. nail set; thence, North 01 Degrees 37 Minutes 25 Seconds East, 275.26 feet to a point; thence, North 04 Degrees 42 Minutes East, 275.66 feet to a point; thence, North 05 Degrees 10 Minutes 40 Seconds East, 386.39 feet to a point; thence, North 11 Degrees 47 Minutes East, 220.21 feet to the point of beginning and containing 5.80 acres.

Subject to all easements and rights of way of record.

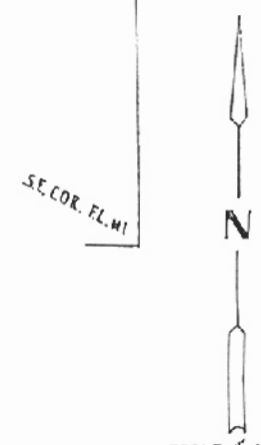
