Commencing at the northeast corner of Lease Lot 3 and the southeast corner of Lease Lot 1, thence on an assumed bearing North 66°35'54" West 2,662.07 feet to a found iron pin on the north line of a 10.49 acre tract described in Volume 44 Page 36 of the Athens County Official Records, THE TRUE POINT OF BEGINNING; thence leaving the north line of said 10.49 acre tract South 10°25'55" West 210.54 feet to a set iron pin; thence South 86°27'29" West (passing a set iron pin at 320.80 feet) for a total distance of 351.57 feet to a point in the center of Athens County Road 17; thence along the center of said Athens County Road 17 North 08°58'37" West 101.94 feet to a point; thence North 10°27'00" West 103.14 feet to a point; thence leaving the said Athens County Road 17 North 86°23'59" East (passing a found iron pin at 25.00 feet) for a total distance of 424.47 feet to the point of beginning containing 1.8148 acres and being a part of a 10.49 acre tract described in Volume 44 Page 36 of the Athens County Official Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.
