Commencing at the northwest corner of said Lease Lot 4; thence on an assumed bearing along the north line of said Lease Lot North 88 degrees 55 minutes 06 seconds East, a distance of 1318.43 feet to a found iron pin\* at the northeast corner of a 1.473 acre tract described in Volume 284 Page 950 of the Athens County Official Deed Records and the northwest corner of a 5.005 acre tract described in Volume 294 Page 746 of the Athens County Official Deed Records; thence along the east line of said 1.473 acre tract and the west line of said 5.005 acre tract South 13 degrees 32 minutes 09 seconds East, a distance of 258.68 feet to a found iron pin at the southeast corner of said 1.473 acre tract, THE TRUE POINT OF BEGINNING; thence along the east line of a 5.83 acre tract described in Volume 219 Page 383 of the Athens County Official Deed Records and the west line of said 5.005 acre tract South 13 degrees 31 minutes 55 seconds East, a distance of 55.06 feet to a set iron pin; thence leaving the east line of said 5.83 acre tract and the west line of said 5.005 acre tract North 83 degrees 49 minutes 00 seconds West, a distance of 168.78 feet to a found iron pin at the southwest corner of said 1.473 acre tract; thence along the south line of said 1.473 acre tract North 77 degrees 08 minutes 40 seconds East, a distance of 158.90 feet to the point of beginning and containing 0.1004 acre, and being a part of a 5.83 acre tract described in Volume 219 Page 383 of the Athens County Official Deed Records.


