Commencing at the northwest corner of said Lease Lot 4; thence along the north line of said Lease Lot 4. North 88 degrees 56 minutes 06 seconds East, a distance of 1024.77 feet to a point, THE TRUE POINT OF BEGINNING; thence leaving the north line of said Lease Lot 4. South 32 degrees 33 minutes 48 seconds East (passing a set iron pin at 30.27 feet) for a total distance of 207.65 feet to a set iron pin; thence South 0 degrees 59 minutes 29 seconds East, a distance of 282.76 feet to a set iron pin; thence South 7 degrees 27 minutes 42 seconds East, a distance of 190.00 feet to a set iron pin; thence South 29 degrees 07 minutes 41 seconds East, a distance of 260.36 feet to a set iron pin; thence South 49 degrees 48 minutes 27 seconds East, a distance of 111.93 feet to a set iron pin; thence South 85 degrees 26 minutes 31 seconds East, a distance of 172.99 feet to a found iron pin on the Grantor's East property line; thence along the grantor's cast property line North 13 degrees 28 minutes 03 seconds West (passing a found iron pin at 287.04 feet) for a total distance of 992.30 feet to a point, the grantor's northeast property corner; thence South 88 degrees 56 minutes 06 seconds West (passing a found iron pin at 192.70 feet) for a total distance of 294.96 feet to the point of beginning and containing 5.8280 acres, and being a part of a tract described as tract 2 in Volume 378. Page 71 of the Athens Country Deod Records.

Note: Unless otherwise noted, all set from plus are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.
