Commencing at a previously found stone, the southeast corner of said Lease Lot 2; thence along the south line of said Lease Lot 2 North 85 degrees 23 minutes 55 seconds West 1001.41 feet to a point, said point being THE TRUE POINT OF BEGINNING; thence leaving the south line of said Lease Lot 2 North 05 degrees 42 minutes 04 seconds East 225.36 feet to a point; thence North 84 degrees 17 minutes 56 seconds West 70.00 feet to a previously set iron pin the southwest corner of a 22.00 acre tract described in Volume 379 Page 193 of the Athens County Deed Records; thence along the west property line of said 22.00 acre tract North 24 degrees 50 minutes 02 seconds West (passing a previously set iron pin at 395.56 feet) for a total distance of 617.31 feet to a previously set iron pin at the southeast corner of a 0.840 acre tract; thence along the south property line of said 0.840 acre tract South 64 degrees 31 minutes 10 seconds West 288.80 feet to a previously set iron pin at the southwest corner of said 0.840 acre tract; thence along a random line South 07 degrees 30 minutes 29 seconds East 132.14 feet to a set iron pin; thence South 04 degrees 41 minutes 30 seconds West (passing a set iron pin at 200.45 feet) for a total distance of 490.32 feet to a set iron pin on the south line of Lease Lot 2; thence along the south line of said Lease Lot 2 South 85 degrees 23 minutes 55 seconds East 592.00 feet the point of beginning containing 7.4233 acres and being part of the remaining 30.75 acres which was surveyed out of a 66.50 acre tract described in Volume 331 Page 41 of the Athens County Deed Records.
