Situated in Lease Lots 2 and 4. Sections 29 and 30, Alexander Township, Town 8, Range 14, Athens County, Ohio and described as follows:

Commencing at a stone* at the northwest corner of Lease Lot 4 of Section 29, said stone being 1018.12 feet left of U.S. Route 50 Station 378 + 37.50 in the centerline of a survey made in 1970 by the Ohio Department of Highways, of U.S. Route 50; thence on an assumed bearing along a random line North 28 degrees 32 minutes 06 seconds East, a distance of 2803.39 feet to a found stone at the grantors southwest property corner, THE TRUE POINT OF BEGINNING; thence along the grantor's west property line North 4 degrees 15 minutes 42 seconds East, passing a found iron pin at 531.44 feet, for a total distance of 556.20 feet to a point in Alexander Township Road 30; thence along said road the following two bearings and distances: 1) North 84 degrees 17 minutes 38 seconds East, a distance of 132.61 feet to a point; thence 2) North 78 degrees 31 minutes 15 seconds East, a distance of 73.49 feet to a point on the west line of a 3.46 acre tract described in Volume 334 Page 261; thence along the west line of said 3.46 acre tract South 11 degrees 10 minutes 39 seconds East, a distance of 30.18 feet to a point; thence along the south line of said 3.46 acre tract the following two bearings and distances: 1) North 88 degrees 27 minutes 12 seconds East, a distance of 189.40 feet to a point; thence 2) North 76 degrees 11 minutes 48 seconds East, a distance of 411.79 feet to an iron pin found on the westerly right of way line of U.S. Route 50; thence along said westerly right of way line the following three bearings and distances: 1) South 9 degrees 11 minutes 25 seconds West, a distance of 154.16 feet to an iron pin found; thence 2) South 27 degrees 22 minutes 37 seconds West, a distance of 451.92 feet to an iron pin found; thence 3) South 17 degrees 08 minutes 02 seconds West, a distance of 221.42 feet to an iron pin found on the grantor's south property line; thence leaving the westerly right of way line of U.S. Route 50 and along the grantor's south property line North 78 degrees 39 minutes 31 seconds West, a distance of 553.52 feet to the POINT OF BEGINNING and containing 9.89 acres, and being a part of a 244.05 acre tract described in Volume 236 Page 545 of the Athens County Deed Records. There are 6.96 acres in Lease Lot and Section 30 and 2.93 acres in Lease Lot 2 and Section 29.

*denotes calculated location based on a previous survey by the Ohio Department of Transportation.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.

The precision of the field survey is 0.03 feet error per 10,000 feet traverse.


The area computes to be 9.89 acres.
