Situated in Section 30, Lease Lot 1, Town 8, Range 14, Alexander Township, Athens County, Ohio and being more particularly described as follows;

Beginning an the northeast corner of the Kelson Kight, etal. 5.004 acres tract as recorded in Volume 355, Page 795 Athens County Deed Records, said corner being on the ease line of Lease Lot 1; thence N 68°58'44" W 181.79 feet to the point of beginning of the tract herein described; thence continuing N 68°58'44" W 374.10 feet to an iron pin found (passing an iron pin set at 322.56 feet; thence N 7°00'01" E 190.72 feet to an iron pin found; thence along a curve to the left having a radius of 34.92 feet, the long chord of which bears N 32°50'35" W 44.76 feet; thence S 72°40'46" E 79.97 feet to an iron pin set; thence S 73°40'15" E 112.83 feet to an iron pin set; thence S 72°35'49" E 223.24 feet to an iron pin set in the center of a ravine; thence S 11°13'34" W 243.46 feet to the point of beginning containing 2.000 acres.



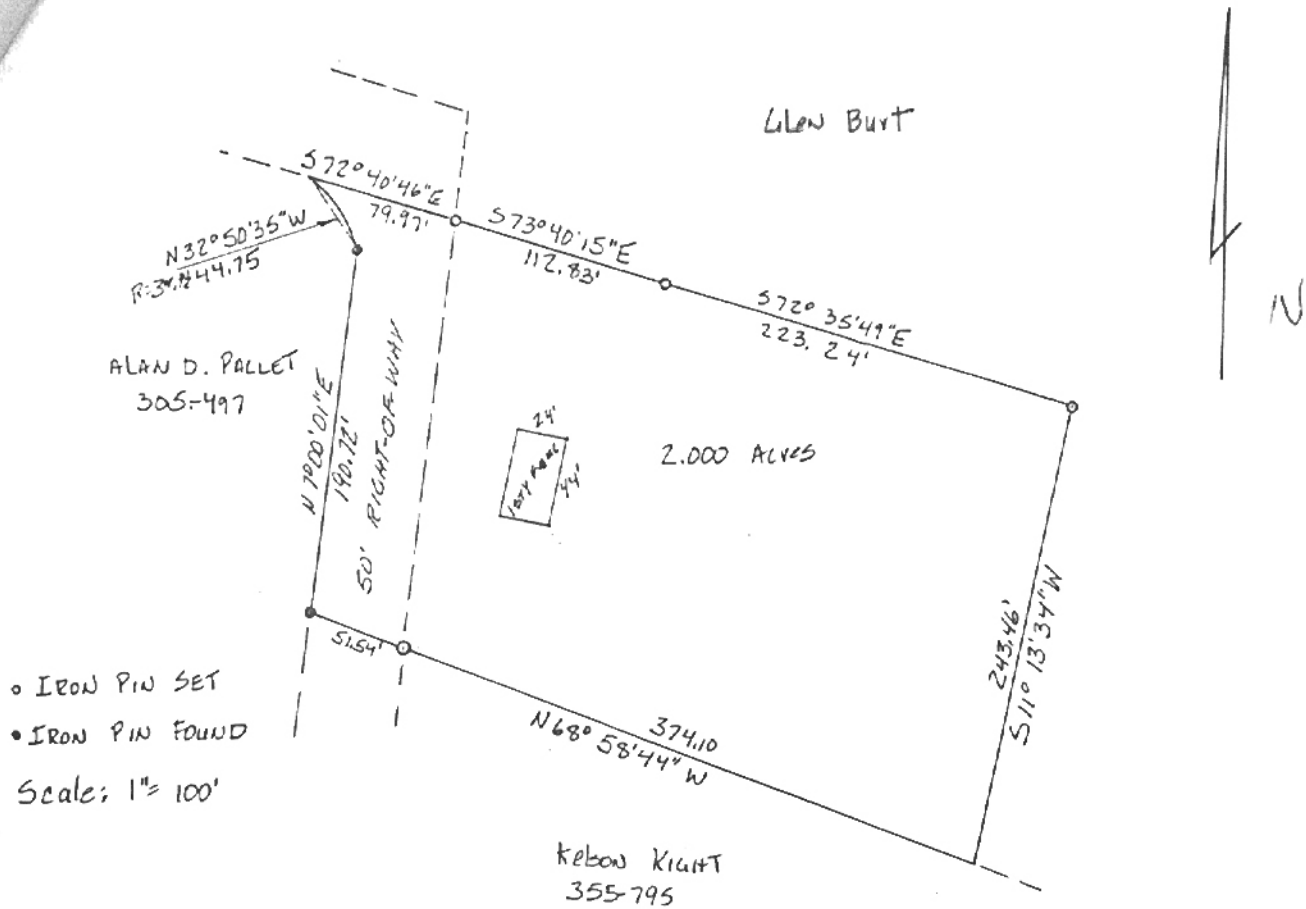
