Commencing at the southwest corner of said Section 33; thence along the west line of said Section 33 on an assumed bearing of North 0 degrees 06 minutes 00 seconds West, a distance of 352.74 feet to a point, THE TRUE POINT OF BEGINNING; thence continuing North 0 degrees 06 minutes 00 seconds West along said Section line, a distance of 124.86 feet to a point (said point is South 00 05'58" East 162.66 feet from the southwest corner of a 1.23 acre tract described in Volume 314 Page 177 of the Athens County Deed Records); thence leaving the said Section line and along an arbitrary line South 89 degrees 43minutes 20 seconds East (passing a set iron pin at 14.21 feet) for a total distance of 346.49 feet to a set iron pin; thence South 0 degrees 16 minutes 39 seconds West, a distance of 124.86 feet to a set iron pin; thence North 89 degrees 43 minutes 20 seconds West (passing a set iron pin at 333.48 feet) for a total distance of 345.67 feet to the POINT OF BEGINNING and containing 1.0 (0.992) acre, and being a part of a 50.79 acre tract described in Volume 112 Page 612 of the Athens County Official Deed Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed Leonard F. Swoyer R.L.S. 6765.

Commencing at a set iron pin at the southeast corner of the above described 1.0 acre tract, THE TRUE POINT OF BEGINNING; thence North 0 degrees 16 minutes 39 seconds East, a distance of 124.86 feet to a set iron pin at the northeast corner of the above described 1.0 acre tract; thence along the extension of the north line of said 1.0 acre tract South 89 degrees 43 minutes 20 seconds East, a distance of 85.67 feet to a point in the existing ravine; thence along the ravine South 19 degrees 28 minutes 43 seconds East, a distance of 132.67 feet to a point; thence along the extension of the south line of said 1.0 acre tract North 89 degrees 43 minutes 20 seconds West, a distance of 130.52 feet to the POINT OF BEGINNING and containing 0.310 acre, and being a part of a 50.79 acre tract described in Volume 112 Page 612 of the Athens County Deed Records.


