Situated in the continuest quarter of Section 33, Town 8, Range 14, Alexander Township, Athens County,

Commencing at the southwest corner of said Section 33; thence on an assumed bearing of North 0 degrees 06 minutes 00 second West along the west line of said Section 33, a distance of 178.67 feet to a set from pin, THE TRUE POINT OF BEGINNING; thence continuing along said Section line North 0 degrees 06 minutes 00 seconds West, a distance of 174.07 feet to a point, the southwest corner of a 1.00 acre tract described in Volume 165 Page 406 of the Athens County Official Deed Records; thence leaving the said Section line and along the south property line of said 1.0 acre tract South 89 degrees 42 minutes 37 seconds East (passing a found iron pin at 12.19 feet) for a total distance of 345.69 feet to a found iron pin, the southeast corner of said 1.00 acre tract; thence along the east property line of said 1.00 acre tract North 0 degrees 16 minutes 55 seconds East, a distance of 124.89 feet to a found iron pin the northeast corner of said 1.00 acre tract; thence continuing N 00 degrees 16 minutes 55 seconds East along the projection of said east property line, a distance of 101.44 feet to a set iron pin on the south side of a fifty foot casement described in Volume 37 Page 228 of the Athens County Deed Records; thence along the south line of said easement on a non-tangential curve to the right a distance of 143.12 feet, said curve has a radius of 299.98 fcct, a central angle of 27 degrees 20 minutes 11 seconds, and a chord which bears South 59 degrees 54 minutes 35 seconds East a distance of 141.77 feet to a point; thence South 46 degrees 16 minutes 31 seconds East, a distance of 33,53 feet to a point; thence along a tangential curve to to the left having an arc distance of 147,79 feet, a radius of 142,02 feet, a central angle of 59 degrees 37 minutes 27 seconds, and a chord which bears South 76 degrees 05 minutes 15 seconds East a distance of 141.21 feet to a set iron pin; thence leaving the said southerly easement line North 87 degrees 49 minutes 14 seconds East, a distance of 578.64 feet to a set iron pin; thence South 0 degrees 23 minutes 12 seconds East, a distance of 104.51 feet to a set iron pin; thence South 79 degrees 48 minutes 20 seconds West, a

distance of 648.96 feet to a set iron pin; thence South 68 degrees 59 minutes 50 seconds West, a distance of 96.09 feet to a set iron pin; thence South 84 degrees 08 minutes 58 seconds West, a distance of 191.10 feet to a set iron pin; thence communing South 84 degrees 08 minutes 58 seconds West along said line, a distance of 145.86 feet to a set iron pin; thence South 88 degrees 18 minutes 49 seconds West, a distance of 145.84 feet to the point of beginning and containing 5.0001 acres, and being a part of a tract described in Volume 112 Page 612 of the Athens County Deed Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Sweyer R.L.S. 6765.


