Commencing at an iron pin at the southeast corner of Farm Lot 5, said iron pin is THE TRUE POINT OF BEGINNING; thence along the east line of Farm Lot 5 and the center of Athens County Road 78 on an assumed bearing North 05°30' East 50.00 feet to an iron pin, the southeast corner of a 5.00 acre tract described in Volume 338 Page 473 of the Athens County Deed Records; thence along the south property line of said 5.00 acre tract and leaving the said Athens County Road 78 North 82°43'36" West 609.08 feet to an iron pin at the southwest corner of said 5.00 acre tract; thence South 05°30' West 50.00 feet to a point on the south property line of a 24.5 acre tract described in Volume 245 Page 679 of the Athens County Deed Records; thence along said south property line South 82°43'36" East 609.08 feet to the point of beginning containing 0.6988 acre and being part of a 24.5 acre tract described in Volume 245 Page 679 of the Athens County Deed Records.

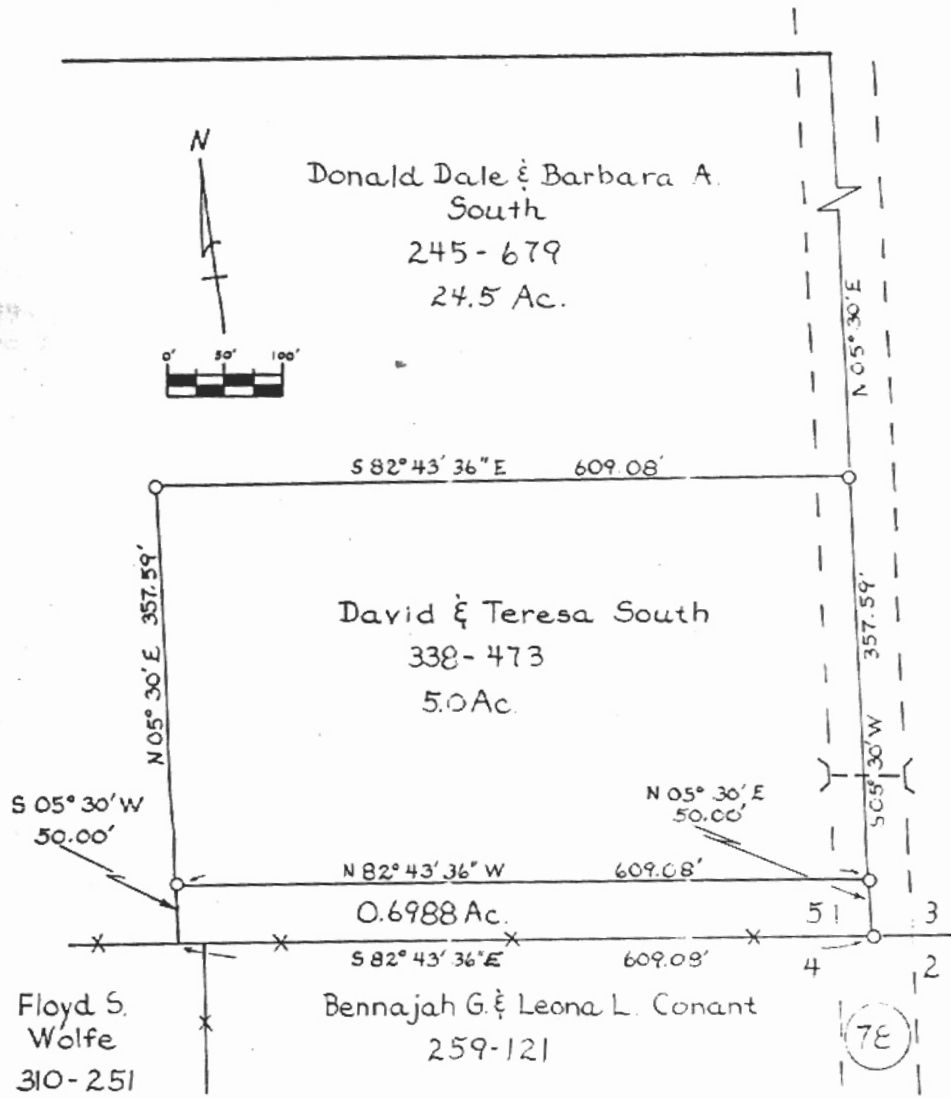
