Commencing at the southeast corner of said Farm Lot 4; thence along the east property line of a 3.79 acre tract described in Volume 331 Page 607 of the Athens County Deed Records on an assumed bearing North 00°37'00" East 1,022.87 feet to the northeast corner of said 3.79 acre tract, THE TRUE POINT OF BEGINNING; thence along the north property line of said 3.79 acre tract South 86°00'00" West 173.75 feet to a found iron pin, the northwest corner of said 3.79 acre tract; thence North 01°12'04" East 52.70 feet to a set iron pin; thence North 86°00'00" East 173.21 feet to a set iron pin; thence South 0°37'00" West 52.65 feet to the point of beginning containing 0.2090 acres and being a part of a tract described in Volume 365 Page 811 of the Athens County Deed Records. The above described 0.2090 acres is to be continuous and contiguous with a 3.79 acre tract described in Volume 331 Page 607 of the Athens County Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.

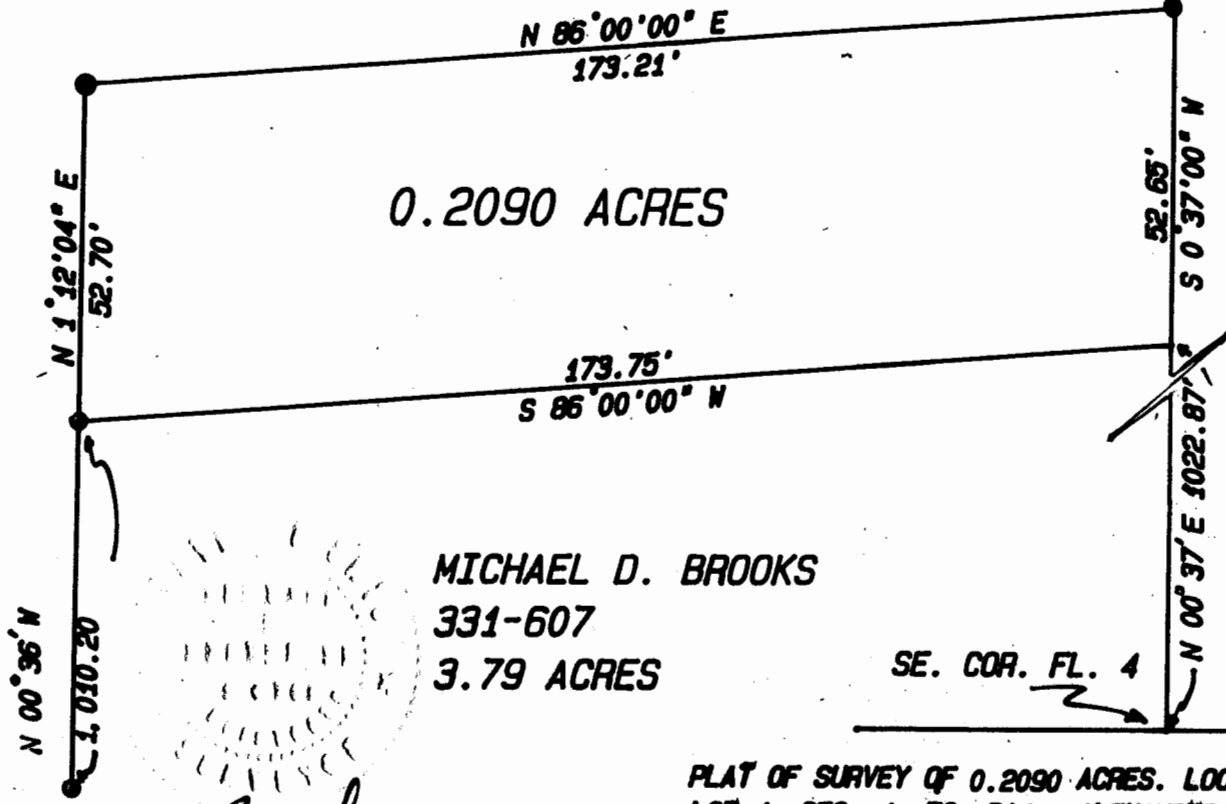
