Commencing at the northwest corner of said Farm Lot 4, THE TRUE POINT OF BEGINNING; thence along the north line of said Farm Lot 4 on an assumed bearing of North 90° East 660 feet to the northwest corner of a 12 acre tract described in Volume 316 Page 665 of the Athens County Deed Records; thence along the west line of said 12 acre tract South 00° West 792.00 feet to the southwest corner of said 12.0 acre tract; thence North 90° -West on a line which is the extension of the south line of the aforesaid 12.0 acre tract 660 feet to the west line of aforesaid Farm Lot 4; thence along the west line of said Farm Lot 4 North 00° East 792.00 feet to the point of beginning containing approximately 12 acres.

The above described 12 acre tract is a part of a tract described in Volume 73 Page 512 of the Athens County Official Deed Records.
