Situated in Lease Lot 2 of Section 4, Town 8, Range 14, Alexander Township, Athens County, Ohio and described as follows:

Commencing at a fence corner (dead stump) at the northeast corner of said Lease Lot 2 on the grantor's north line; thence leaving the north line of said Lease Lot 2 on an assumed bearing along an arbitrary line the following ten bearings and distances: 1) South 7 degrees 03 minutes 34 seconds West, a distance of 196.43 feet to a set iron pin; thence 2) South 62 degrees 19 minutes 21 seconds West, a distance of 99.94 feet to a set iron pin; thence 3) South 73 degrees 23 minutes 30 seconds West, a distance of 218.35 feet to a set iron pin; thence 4) North 49 degrees 58 minutes 44 seconds West, a distance of 118.78 feet to a set iron pin; thence 5) South 26 degrees 04 minutes 46 seconds West, a distance of 73.30 feet to a set iron pin; thence 6) South 29 degrees 28 minutes 04 seconds West, a distance of 115.91 feet to a set iron pin; thence 7) South 31 degrees 57 minutes 17 seconds West, a distance of 202.12 feet to a set iron pin; thence 8) South 43 degrees 06 minutes 40 seconds West, a distance of 79.25 feet to a set iron pin; thence 9) South 17 degrees 19 minutes 14 seconds West, a distance of 156.00 feet to a set iron pin; thence 10) South 82 degrees 22 minutes 51 seconds West, passing set iron pins at 50.00 feet and 341.74 feet, for a total distance of 361.21 feet to a point in Alexander Township Road 65 on the grantor's west line; thence along said road and the grantor's west line North 23 degrees 08 minutes 51 seconds West, a distance of 90.00 feet to a point at the southwest corner of a 5.00 acre tract described in Volume 243 Page 6 of the Athens County Official Deed Records; thence leaving said road and along the grantor's west line and the south line of said 5.00 acre tract North 66 degrees 51 minutes 09 seconds East, passing a found iron pin at 15.00 feet, and a set iron pin at 437.24 feet, for a total distance of 487.24 feet to a found iron pin at the southeast corner of said 5.00 acre tract; thence along the grantor's west line and the east line of said 5.00 acre tract North 23 degrees 06 minutes 12 seconds East, a distance of 345.54 feet to an iron pin* at the northeast corner of said 5.00 acre tract and the southeast corner of a second 5.00 acre tract described in Volume 91


