Situated in Farm Lot 3, Section 4, Alexander Township, Town 8, Range 14, Athens County, Ohio and described as follows:

Commencing at the southeast corner of Farm Lot 3; thence North 440.22 feet (6.67 chains) to a point in the center of Athens County Road 16 (Deed V.274-P.404); thence along the center of said road and along the south line of a 15.81 acre tract described in Volume 274 Page 404 of the Athens County Deed Records North 82°30' West 365 feet(Deed V.274P.404)to a point described as being the southeast corner of a 0.74 acre tract described in Volume 52 Page 874 of the Athens County Deed Records; thence along the center of Athens County Road 16 and the south line of said 0.74 acre tract North 82°30' West 135 feet (V.272P.404) to a railroad spike set at the southwest corner of said 0.74 acre tract, said railroad spike set is also THE TRUE POINT OF BEGINNING; thence continuing along the center of Athens County Road 16 and the south line of the aforesaid 15.81 acre tract the following three bearings and distances:

- 1) North 84°55'23" West 260.70 feet to a railroad spike set; thence
- 2) North 85°24'35" West 155.04 feet to a point; thence

marker inscribed L.F. Swoyer R.L.S. 6765.

- 3) South 89°14'40" West 83.55 feet to a point; thence leaving Athens County Road 16 on a random line the following four bearings and distances:
- 1) North 08°55'05" East (passing an iron pin set at 25.85 feet) for a total distance of 204.46 feet to an iron pin set; thence
- 2) North 86°35'56" East 52.61 feet to an iron pin set; thence
- 3) North 88°29'26" East 233.64 feet to an iron pin set; thence
- 4) South 89°16'25" East 180.01 feet to a found one inch square iron at the northwest corner of the aforesaid 0.74 acre tract; thence along the west line of said 0.74 acre tract South 00°00'00" West 243.36 feet to the point of beginning and containing 2.4566 acres and being a part of a 15.07 acre tract described in Volume 274 Page 404 of the Athens County Deed Records.

  Note: Unless otherwise noted all set iron pins are 1/2 inch diameter reinforcing bar 30 inches in length and capped with a plastic identification


