Situated in Lease Lot 6, Section 6, Alexander Township, Town 8, Range 14, Athens County, Ohio and described as follows:

Commencing at a stone* at the southeast corner of Lease Lot 6; thence on an assumed bearing along the east line of said Lease Lot 6 and the west line of Lease Lot 5 the following two bearings and distances: 1) North 1 degrees 44 minutes 12 seconds West, a distance of 615.73 feet to an iron pin*; thence 2) North 0 degrees 29 minutes 11 seconds East, a distance of 1091.16 feet to a found iron pin at the grantor's southeast corner, the northeast corner of a 39.39 acre tract described in Volume 151 Page 722 of the Athens County Official Deed Records, the southwest corner of a 68.75 acre tract described in Volume 315 Page 829 of the Athens County Deed Records; thence along the south line of the grantor and the north line of said 39.39 acre tract South 87 degrees 38 minutes 15 seconds West, a distance of 1443.96 feet to a fence corner post at the northwest corner of said 39.39 acre tract, at the northeast corner of a 0.706 acre tract described in Volume 369 Page 233 of the Athens County Deed Records; thence along the grantor's south line and north line of said 0.706 acre tract North 74 degrees 16 minutes 12 seconds West, a distance of 273.41 feet to a found railroad spike in Athens County Road 21 at the grantor's southwest corner, the northwest corner of said 0.706 acre tract on the east line of a 9.36 acre tract described in Volume 130 Page 824 of the Athens County Official Deed Records; thence along said road and the west line of the grantor and the east line of said 9.36 acre tract North 8 degrees 32 minutes 56 seconds East, a distance of 120.83 feet to a found railroad spike at the northeast corner of said 9.336 acre tract, the southeast corner of a 19.99 acre tract described in Volume 118 Page 417 of the Athens County Official Deed Records; thence along said road and the west line of the grantor and the east line of said 19.99 acre tract the following five bearings and distances: 1) North 1 degrees 05 minutes 46 seconds East, a distance of 12.85 feet to a point; thence 2) North 1 degrees 05 minutes 46 seconds East along said line, a distance of 46.99 feet to a point; thence 3) North 9 degrees 51 minutes 36 seconds East, a distance of 307.55 feet to a point; thence 4) North 29 degrees 14 minutes 03 seconds East, a distance of 119.44 feet to a point; thence 5) North 39 degrees 56 minutes 03 seconds East, a distance of 26.31 feet to a point, THE TRUE POINT OF BEGINNING; thence continuing along said road and the grantor's west line and the east line of said 19.99 acre tract and east line of a 0.76 acre tract described in Volume 12 Page 132 of the Athens County Official Deed Records North 39 degrees 56 minutes 03 seconds East, a distance of 98.77 feet to a point; thence leaving said road and along a new line the following two bearings and distances: 1) South 81 degrees 35 minutes 09 seconds East, passing a set iron pin at 39.19 feet, for a total distance of 103.39 feet to a set iron pin; thence 2) South 59 degrees 41 minutes 01 second East, passing a set iron pin at 699.28 feet, for a total distance of 904.51 feet to a point in a ravine; thence up said ravine the following four bearings and distances: 1) South 69 degrees 42 minutes 58 seconds West, a distance of 112.25 feet to a point; thence 2) South 86 degrees 29 minutes 13 seconds West, a distance of 179.81 feet to a point; thence 3) South 67 degrees 53 minutes 57 seconds West, a distance of 168.27 feet to a point; thence 4) North 80 degrees 16 minutes 51 seconds West, a distance of 40.31 feet to a point; thence leaving said ravine and along a new line the following four bearings and distances: 1) North 19 degrees 46 minutes 54 seconds West, a distance of 73.23 feet to a set iron pin; thence 2) North 54 degrees 11 minutes 13 seconds West, a distance of 239.45 feet to a set iron pin; thence 3) North 66 degrees 39 minutes 05 seconds West, a distance of 130.28 feet to a set iron pin; thence 4) North 27 degrees 48 minutes 45 seconds West, passing a set iron pin at 247.82 feet, for a total distance of 273.32 feet to the POINT OF BEGINNING and containing 5.174 acres, and being a part of a 44.90 acre tract described in Volume 135 Page 698 of the Athens County Official Deed Records. *Denotes calculated location of monument based on previous survey. Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. 
