A CONTINUOUS AND CONTIGUOUS TRANSFER BETWEEN ADJOINING OWNERS

Commencing at a found stone on the west line of Section 27 and the east line of Section 33 at the southwest corner of Fraction 24 and the southwest corner of a 100 acre tract described in Volume 370 Page 793 of the Athens County Deed Records; thence along the east line of Section 33 and the west line of Section 27 and Fraction 24 and the west line of said 100 acre tract North 1 degrees 09 minutes 37 seconds East, a distance of 465.81 feet to a set iron pin on the east line of a 5.0 acre tract described in Volume 171 Page 816 of the Athens County Official Deed Records, THE TRUE POINT OF BEGINNING; thence along an arbitrary line the following four bearings and distances: 1) South 89 degrees 27 minutes 03 seconds West, a distance of 88.99 feet to a point; thence 2) North 85 degrees 08 minutes 09 seconds West, a distance of 313.10 feet to a set iron pin; thence 3) North 74 degrees 51 minutes 01 second West, a distance of 169.30 feet to a set iron oin; thence 4) North 59 degrees 40 minutes 05 seconds West, a distance of 238.54 feet to a found iron pin on the north line of aforesaid 5.0 acre tract on the south line of an 18.99 acre tract described in Volume 135 Page 43 of the Athens County Official Deed Records; thence along the north line of said 5.0 acre tract and the south line of said 18.99 acre tract South 76 degrees 46 minutes 50 seconds East, passing a found iron pin at 781.47 feet, for a total distance of 791.43 feet to a point at the northeast corner of said 5.0 acre tract and the southeast corner of said 18.99 acre tract on the east line of Section 33 and the west line of aforesaid 100 acre tract on the west line of Section 27 and Fraction 24 ; thence along the west line of said 5.0 acre tract and the west line of Section 33 and the east line of said 100 acre tract and the west line of Section 27 and Fraction 24 South 1 degrees 09 minutes 37 seconds West, a distance of 9.43 feet to the POINT OF BEGINNING and containing 0.884 acres, and being a part of a 5.0 acre tract described in Volume 171 Page 816 of the Athens County Deed Records. 
