Situate in Section 34, Town 6, Range 13, Ames Township, Athens County, State of Ohio and being more particularly described as follows:

Commencing at the Southwest corner of Section 34; thence N 90° E along the South line of said Section 34, 3,479.52 feet (52.72 chains) to a stone; thence N 00° E along one of the Grantor's original lines, 2,481.93 feet (37.60 chains) to a stone; thence N 90° W along another of the Grantor's East lines, 143.22 feet (2.17 chains) to a stone; thence N 0° E along another of the Grantor's East lines, 2,151.60 feet (32.60 chains) to a point on the center Township Road No. 335, said point also being in the Northeastern corner; thence the following courses of the said centerline of Ames Township Road No. 335 and most Northerly lines:

- N 42° 31' 30" W, 111.24 feet to a P.K. nail set;
- S 70° 16' 00" W, 111.73 feet to a P.K. nail set;
- S 68° 04' 22" W, 235.63 feet to a railroad spike set, said

railroad spike set also being the real point of beginning of the tract herein described:

Thence S 10° 40' 42" W along a random line (approximately parallel to, and, three - 3 - feet West of the edge of an existing driveway), 142.47 feet to a 1" iron pipe set adjacent to an existing gate post, passing through a 1" iron pipe set for reference at 30.00 feet; thence S 02° 09' 06" E along a random line, 372.71 feet to an iron bolt set at the base of an existing fence post (being the fifth fence post Southwesterly of an existing fence corner); thence the following courses and distances approximately along and with an existing hayfield-pasture fence:

- S 26° 33' 18" W, 146.79 feet to a 1" iron pipe set;
- S 19° 47' 46" W, 133.86 feet to a 1/2" iron pin set;
- N 61° 01' 25" W, 140.85 feet to a 1/2" iron pipe set;
- N 04° 15' 40" E, 143.07 feet to a 3/4" iron pipe set;
- N 35° 44' 26" E, 245.42 feet to a 3/4" iron pipe set;
- N 19° 41' 36" E, 57.93 feet to a 1" iron pipe set;
- N 15° 01' 06" W, 68.30 feet to a 1" iron pipe set;
- N 59° 50' 18" W, 184.85 feet to a 1" iron pin set;
- N 63° 27' 10" W, 208.43 feet to a 3/4" iron pipe set;
- N 14° 55' 54" E, 182.55 feet to a 1 1/2" iron pipe set;
- N 18° 53' 40" E, 249.17 feet to a 1/2" iron pipe set in the

Grantor's Northerly line; thence N 84° 40' 12" E along the said Grantor's Northerly line, 139.07 feet to a railroad spike set in another of the Grantor's Northeastern corners, passing through a 1" iron pipe set for reference at 119.07 feet; thence the following courses and distances along the centerline of Ames Township Road No. 335 and the Grantor's Northerly line:

- S 04° 25' 15" E, 88.28 feet to a mine spike set;
- S 19° 52' 00" E, 77.47 feet to a mine spike set;
- S 30° 48' 18" E, 115.58 feet to a mine spike set;
- S 54° 43' 49" E, 72.20 feet to a mine spike set;
- S 80° 30' 35" E, 73.79 feet to a mine spike set;
- N 87° 23' 57" E, 86.22 feet to the point of beginning and

containing a total area of 9.0010 acres, of which, 6.6688 acres comes out of an existing 23.35 acre First Tract and 2.3322 acres comes out of an existing 155.25 acre Second Tract.

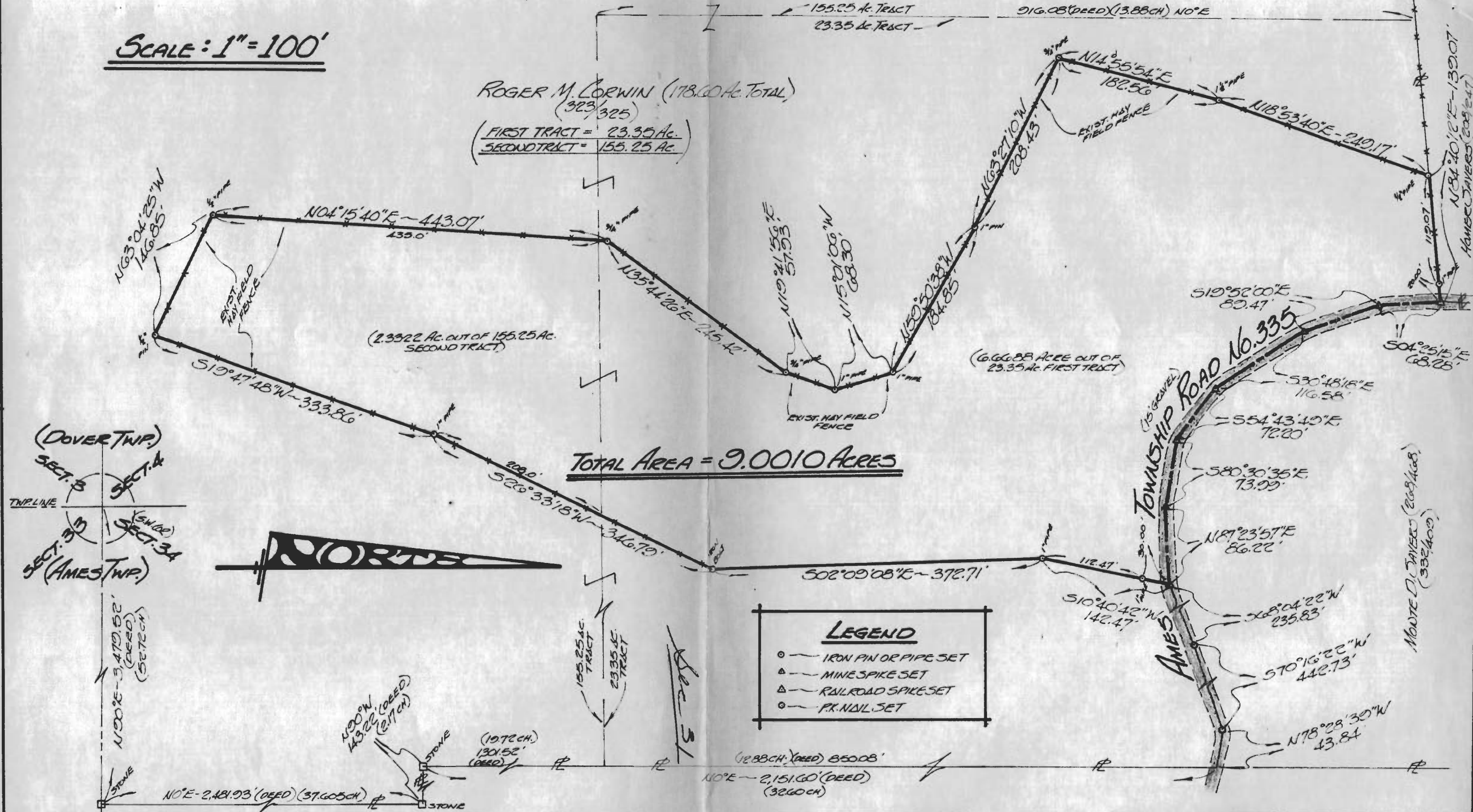

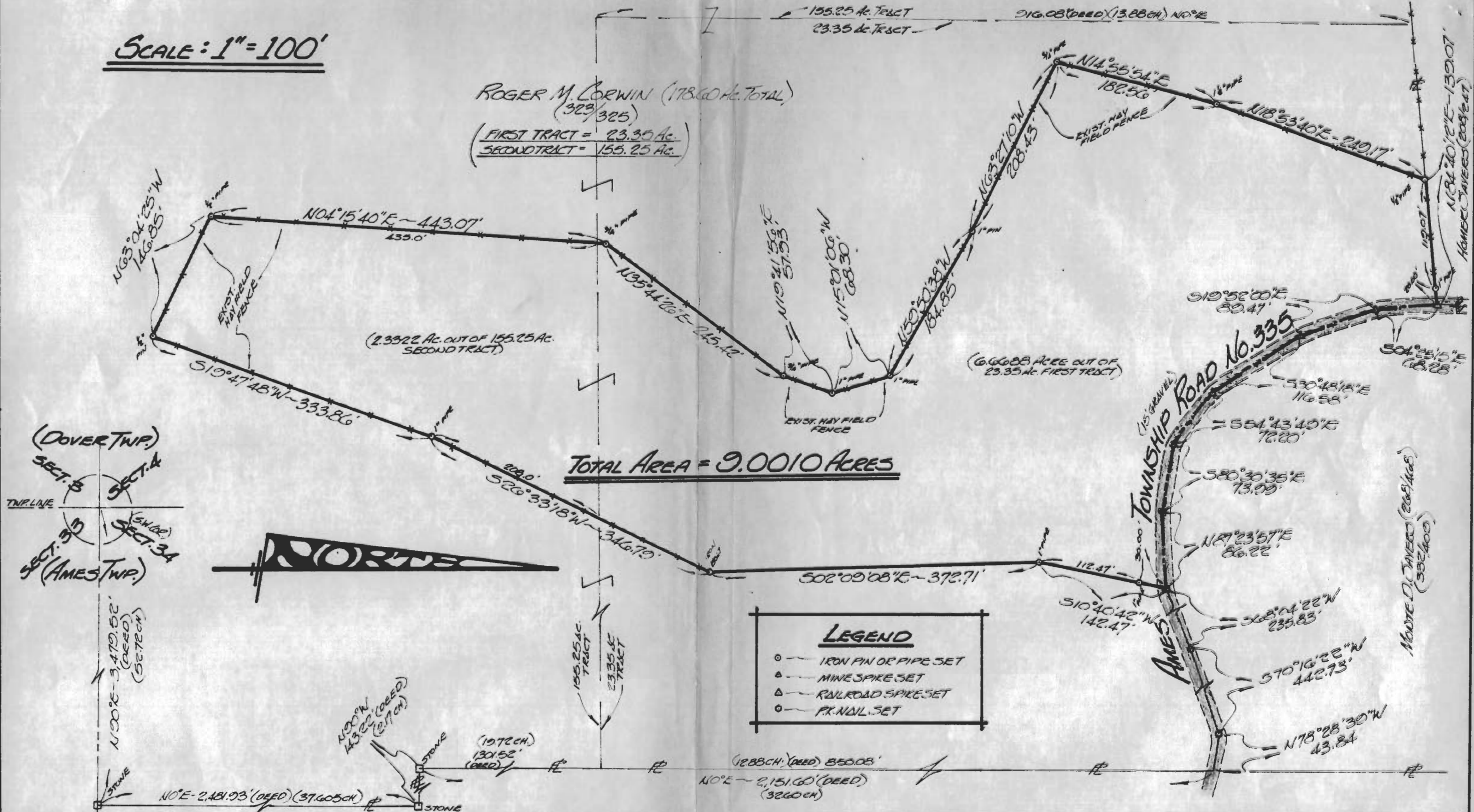
