

Situate in Fraction 12, Section 9, and Fraction 12, Section 10, T6, R13, Ames Township, Athens County, Ohio. Being a part of the Betty Calentine parcel as described in D.R. Vol. 371, PG. 393, Athens County Recorder's Office and being more fully described as follows:

Commencing at an iron pin found at the northwest corner of Section 9, thence along the north line of said Section 9 S 86°24'58" E 994.10 feet to an iron pin set, said iron pin being the **Point-of-Beginning** for the parcel herein described;

Thence from this Point-of-Beginning along the north line of Section 9 S 86°25'45" E 647.91 feet to an iron pin set;

Thence leaving north line of Section 9 N 03°34'05" E 157.82 feet to a point in the center of Athens County Road 35 (reference: iron pin set at 127.82 feet);

Thence along the center of said County Road 35 the following six courses:

- S 78°24'42" E 53.36 feet;
- S 88°02'21" E 34.55 feet;
- N 77°19'50" E 158.42 feet;
- N 68°25'39" E 121.23 feet;
- N 55°16'19" E 66.64 feet;
- N 39°57'13" E 181.14 feet to a railroad spike set;

Plat of Survey is attached herewith and made a part thereof.

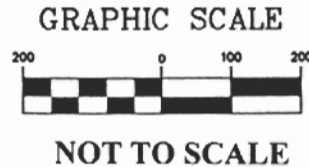
Iron pins set are 5/8"x30" rebar with plastic cap stamped "CANTER 7226".

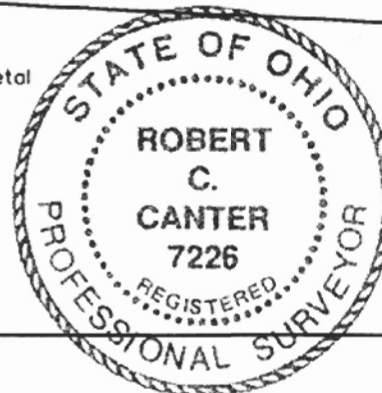
