Situate in F.R. 31, (Section 20) and F.R. 25 (Section 20), Town 6, Range 13, Ames Township, Athens County, State of Ohio and being more particularly described as follows:

Commencing at a point in the Northeast corner of Section 26 and a Westerly corner of F.R. 31 (Northwest corner of Section 20); thence S 0° E along the West line of F.R. 31 (Section 20) and the East line of Section 26, 957.0 feet to a point in the Southwest corner of F.R. 31 and the Northwest corner of F.R. 25; thence N 90° E along the South line of F.R. 31 and the North line of F.R. 25, 1,304.02 feet to a point, said point also being the real point of beginning for the parcel herein described:

Thence N $13^{\circ}44'18''$ E along a line, 92.62 feet to a railroad spike set in the existing centerline of State Route No. 50-A, passing through an iron pipe set at 72.62 feet; thence running along said existing centerline of State Rte. 50-A, Southeastwardly along and with the arc of a curve to the left having a radius of 750.00 feet, with a central angle of $06^{\circ}28'04''$, for a distance of 84.66 feet to a railroad spike set, the long chord of said arc bearing S $76^{\circ}03'10''$ E, 84.62 feet to said railroad spike; thence S $19^{\circ}50'24''$ W along a line, 73.96 feet to a point in the South line of F.R. 31 and the North line of F.R. 25, passing through an iron pipe set at 20.00 feet; thence continuing S $19^{\circ}50'24''$ W along a line, 12.44 feet to a railroad spike set; thence S $49^{\circ}20'09''$ W along a line, 45.75 feet to a railroad spike set; thence S $85^{\circ}55'45''$ W along a line, 82.52 feet to a railroad spike set; thence S $60^{\circ}31'07''$ W along a line, 35.21 feet to a railroad spike set; thence S $38^{\circ}33'57''$ W along a line, 85.59 feet to an iron pipe set; thence S $45^{\circ}34'02''$ W along a line, 251.04 feet to an iron pipe set; thence N $51^{\circ}57'16''$ W along a line, 168.85 feet to an iron pipe set; thence N $30^{\circ}11'55''$ W along a line, 118.25 feet to an iron pipe set; thence N $21^{\circ}08'43''$ W along a line, 93.82 feet to an iron pipe set; thence S $88^{\circ}31'15''$ E along a line, 204.71 feet to an iron pipe set; thence S $88^{\circ}41'30''$ E along a line, 270.15 feet to an iron pipe set; thence N $70^{\circ}53'05''$ E along a line, 58.92 feet to an iron pipe set; thence N $13^{\circ}44'18''$ E

along a line, 5.93 feet to the point of beginning and containing 2.1197 acres, of which 0.1515 acres is in F.R. 31 (Sect. 20) and 1.9682 acres is in F.R. 25 (Sect. 20).
