Wolfe, the Grantors herein, as recorded in Official Record 470 at page 1265 in the Athens County Recorder's Office, Athens County, OH, and, being situate in the SE-1/4 of Section 36, Town-6-North, Range-13-West, Ames Township, Athens County, State of Ohio, USA, and being more particularly described as follows:
