

Description of a 25.007 Acre Tract

Situated in Section 4, Town 6, Range 13, Ames Township, Athens County, State of Ohio, being part of Parcel C010010013300 deeded to Chadwell in Volume 493, Page 1183 of the Official Records of Athens County, Ohio, and being more particularly described as follows:

COMMENCING at a stone found at the Northeast corner of Section 4; thence $S3^{\circ}19'28''W$, 1,162.80 feet along the east line of Section 4 to an iron pin set and said iron pin being the **POINT OF BEGINNING** for the tract herein described:

Thence **South $3^{\circ}19'28''$ West, 530.32 feet** along the east line of said section to an iron pin set;

Thence along new lines created by this survey the following four (4) courses:

1. **North $83^{\circ}20'08''$ West, 840.40 feet** to an iron pin set;
2. **South $69^{\circ}11'08''$ West, 714.77 feet** to an iron pin set;
3. **North $88^{\circ}44'43''$ West, 364.04 feet** to an iron pin set;
4. **North $3^{\circ}47'03''$ East, 758.96 feet** to an iron pin set;

Thence **South $87^{\circ}32'21''$ East, 1,849.17 feet** along the south lines of Chadwell (OR 493-1183 Parcel Two) and McKinley (OR 497-112), passing an iron pin set at 528.54 feet, to the point of beginning and containing 25.007 acres.

Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar, 30 inches in length and capped with a plastic identification marker inscribed Stevens, PS 8716.

Bearings are State Plane Grid NAD83, Ohio South Zone.

Subject to all Easements and Rights of Way of Record.

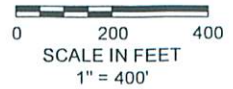
