Commencing at a set iron pin on the south line of Ark Street and the east line of Lancaster Street at the northwest corner of Parcel One described in Volume 261 Page 1414 of the Athens County Official Deed Records and the northwest corner of Lot 201 of W.H. Young's Addition, the said iron pin set is THE TRUE POINT OF BEGINNING;

Thence along the south line of Ark Street, the north line of Parcel One, and the north line of Parcel Two described in Volume 261 Page 1414 of the Athens County Official Deed Records South 79 degrees 49 minutes 03 seconds East, a distance of 110.33 feet to a point at the northeast corner of the said Parcel Two, the northwest corner of Parcel Three described in Volume 261 Page 1414 of the Athens County Official Deed Records, and the northwest corner of Lot 202 of the said subdivision (from which an iron pin set at the northeast corner of the said Parcel Three bears South 79 degrees 49 minutes 03 seconds East, a distance of 20.06 feet);

thence leaving said Ark Street with the east line of the said Parcel Two, the west line of the said Parcel Three, and the west line of Lot 202 of the said subdivision South 14 degrees 35 minutes 36 seconds West, a distance of 30.00 feet to a point at the northeast corner of Parcel Four described in Volume 261 Page 1414 of the Athens County Official Deed Records (from which a found iron pin at the southeast corner of the said Parcel Four bears South 14 degrees 35 minutes 36 seconds West, a distance of 3.00 feet);

thence with the north line of the said Parcel Four, the south line of the said Parcel Two, and the south line of the said Parcel One North 77 degrees 13 minutes 17 seconds West, a distance of 110.06 feet to a point at the northwest corner of the said Parcel Four on the east line of Lancaster Street (from which a found iron pin at the southwest corner of the said Parcel Four bears South 14 degrees 35 minutes 36 seconds West, a distance of 3.00 feet):

thence with the east line of the said Lancaster Street, the west line of Lot 201 of the said subdivision, and the west line of the said Parcel One North 14 degrees 35 minutes 36 seconds East, a distance of 25.00 feet to the point of beginning and containing 0.0690 acre and being a combined description of all of Parcel One and Parcel Two described in Volume 261 page 1414 of the Athens County Official Deed Records.

Commencing at a set iron pin on the south line of Ark Street and the east line of Lancaster Street at the northwest corner of Parcel One described in Volume 261 page 1414 of the Athens County Official Deed Records and the northwest corner of Lot 201 of W.H. Young's Addition;

thence along the south line of Ark Street, the north line of the said Parcel One, and the north line of Parcel Two described in Volume 261 Page 1414 of the Athens County Official Deed Records South 79 degrees 49 minutes 03 seconds East, a distance of 110.33 feet to a point at the northeast corner of the said Parcel Two and the northwest corner of Parcel Three described in Volume 261 page 1414 of the Athens County Official Deed Records, and the northwest corner of Lot 202 of the said W. H. YOUNG subdivison and THE TRUE POINT OF BEGINNING;

thence continuing along the south line of Ark Street, the north line of the said Parcel Three and the north line of Lot 202 of said subdivision South 79 degrees 49 minutes 03 seconds East, a distance of 20.06 feet to a set iron pin at the northeast corner of the said Parcel Three;

thence leaving Ark Street and with the east line of the said Parcel Three through Lot 202 of the said subdivision South 14 degrees 35 minutes 36 seconds West, (passing a set iron pin at 33.91 feet) for a total distance of 76.05 feet to a set iron pin at the southeast corner of the said Parcel Three on the north line of Lot 205 of the said subdivision;

thence with the north line of Lot 205 of the said subdivision, the north line of Lot 204 of the said subdivision, the south line of the First Tract described in Volume 263 Page 1562 of the Athens County Official Deed Records North 75 degrees 23 minutes 46 seconds West, (passing a found iron pin at 20.00 feet) for a total distance of 130.00 feet to a found iron pin at the northwest corner of Lot 204 of the said subdivision, the southwest corner of Lot 201 of the said subdivision, and the southwest corner of the said First Tract on the east line of Lancaster Street;


