Exhibit "A" Legal Description 0.091 Acres

Situate in the Township of Athens, County of Athens, and in the State of Ohio. Being a part of Lease Lot #8 in the Northeast Quarter of Section 1, Twp.-9N, Rng.-14W Ohio Company's Purchase East of the Scioto River, and being more particularly described as follows,

Being a survey of all of a portion of a 41.60 acre parcel conveyed to Mark A. and Sara V. Lee of record and recorded in Official Record 217 page 555 in the Athens County Recorders Office and being further described as follows,

Commencing, for reference, at a 5/8" o.d. rebar found marking the Northeast corner of Lot #1 in Old Coach Highland Subdivision, of record and recorded in Plat Cabinet Envelope #438A, said Lot #1 being conveyed to Mark A. and Sara V. Lee, of record and recorded in Official Record 191 page 783, Thence, **S 18° 38' 08"** E along the East boundary line of Lot #1 the same being a West boundary line of said 41.60 acre parcel conveyed to Lee of which this survey is a part **40.58** feet to a 5/8" o.d. rebar found at an angle point in the East boundary line of Lot #1, the Northernmost corner of and **PRINCIPLE PLACE OF BEGINNING** of the **0.091** acre parcel herein to be described,

Thence, with what represents new lines that cross said 41.60 acre parcel convey to Lee of which this survey is a part the following Two (2) courses and distances,

- 1) S 19° 45' 03" E 149.38 feet to an iron pin set;
- 2) S 08° 24' 02" W 111.93 feet to a 5/8" o.d. rebar found at an angle point in the East boundary line of Lot #1, the same being the West boundary line of said 41.60 acre parcel conveyed to Lee;

Thence, N 07° 43' 58" W along the East line of Lot #1, the same being the West line of said 41.60 acre parcel conveyed to Lee 253.63 feet to the PRINCIPLE PLACE OF BEGINNING.

Said parcel as surveyed contains a total acreage of 0.091 acres more or less.

The Grantees, their heirs, and assigns do hereby acknowledge and agree that this conveyance is subject to the covenant and agreement of the grantees, their heirs, and assigns that this 0.091 acre parcel shall be conveyed continuous and contiguous with Lot #1 of Old Coach Highland Subdivision.

Subject to legal easements, right-of-ways, zoning ordinances, and restrictions of record.

Bearings of the above description are based on the West line of Lot #1 in Old Coach Highland Subdivision, Plat Cabinet Envelope #438A as being N 05° 30' 00" E and is an assumed Meridian used to denote angles only.
