CONTINUOUS AND CONTIGUOUS TRANSFER BETWEEN ADJOINING OWNERS

Situated in Lot 5 of Northpoint Subdivision, Lease Lot 209, Section 11, Athens Township, Town 9, Range 14, Athens County, Ohio and described as follows:

Commencing at a set iron pin at the southeast corner of Lot 5 of the Northpoint Subdivision, THE TRUE POINT OF BEGINNING; thence on an assumed bearing along an arbitrary line the following three bearings and distances: 1) North 13 degrees 21 minutes 06 seconds West, a distance of 61.58 feet to a set iron pin; thence 2) North 15 degrees 13 minutes 33 seconds East, a distance of 31.11 feet to a set iron pin; thence 3) North 28 degrees 28 minutes 28 seconds East, a distance of 148.73 feet to a set iron pin on the east line of Lot 5 and the west line of Lot 6; thence along the east line of Lot 5 and the west line of Lot 6 South 16 degrees 22 minutes 45 seconds West, a distance of 230.00 feet to the POINT OF BEGINNING and containing 0.093 acre, and being a part of Lot 5 of the Northpoint Subdivision. Grantor claims title to above described property by Volume 182 Page 570 of the Athens County Official Deed Records. NOTE: THE ABOVE DESCRIBED 0.093 ACRE TRACT IS TO BE CONTINUOUS AND CONTIGUOUS WITH LOT 6 OF THE NORTHPOINT SUBDIVISION.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


