TRACT A A CONTINUOUS AND CONTIGUOUS TRANSFER BETWEEN ADOINING TRACTS

Situated in Lot 5 of the Northpoint Subdivision, Section 11, Athens Township, Town 9, Range 14, Athens County, Ohio and described as follows:

Commencing at an iron pin* at the northeast corner of said Lot 5; thence on an assumed bearing along the north line of Lot 5 North 70 degrees 00 minutes 22 seconds West, a distance of 82.06 feet to a set iron pin, THE TRUE POINT OF BEGINNING; thence leaving the north line of Lot 5 and along a new property line the following three bearings and distances: 1) South 24 degrees 33 minutes 51 seconds West, a distance of 367.67 feet to a set iron pin; thence 2) South 12 degrees 45 minutes 20 seconds West, a distance of 207.51 feet to a set iron pin; thence 3) South 18 degrees 26 minutes 36 seconds West, passing a set iron pin at 326.34 feet, for a total distance of 352.73 feet to a set iron pin on the south line of Lot 5 on the northerly right of way line of Northpoint Drive; thence along the south line of Lot 5 and the northerly right of way of Northpoint Drive the following two bearings and distances: 1) along a non-tangential curve to the right a distance of 47.35 feet, said curve has a radius of 92.62 feet, a central angle of 29 degrees 17 minutes 28 seconds, and a chord which bears North 41 degrees 04 minutes 37 seconds West a distance of 46.84 feet to an iron pin*; thence 2) North 26 degrees 25 minutes 53 seconds West, a distance of 37.00 feet to an iron pin* at the southwest corner of Lot 5 and southeast corner of Lot 4; thence leaving the northerly right of way line of Northpoint Drive and along the west line of Lot 5 and the east line of Lot 4 the following three bearings and distances: 1) North 18 degrees 10 minutes 25 seconds East, a distance of 300.31 feet to an iron pin*; thence 2) North 8 degrees 40 minutes 05 seconds East, a distance of 189.38 feet to an iron pin*; thence 3) North 23 degrees 48 minutes 36 seconds East, a distance of 391.82 feet to an iron pin* at the northwest corner of Lot 5 and northeast corner of Lot 4; thence along the north line of Lot 5 South 70 degrees 00 minutes 22 seconds East, a distance of 82.06 feet to the POINT OF BEGINNING and containing 1.5420 acres, and being a part of Lot 5 of the Northpoint Subdivision described in Volume 182 Page 570 of the Athens County Official Deed Records. THE ABOVE DESCRIBED 1.5420 ACRE TRACT IS TO BE SUBDIVISION. *Denotes calculated location of monument based on previous survey.

TRACT B A CONTINUOUS AND CONTIGUOUS TRANSFER BETWEEN ADJOINING TRACTS

Situated in Lot 5 of the Northpoint Subdivision, Section 11, Athens Township, Town 9, Range 14, Athens County, Ohio and described as follows:

Commencing at an iron pin* at the northeast corner of aforesaid Lot 5 and the northwest corner of Lot 6 of said Northpoint Subdivision; thence on an assumed bearing along the east line of said Lot 5 and the west line of said Lot 6 the following two bearings and distances: 1) South 25 degrees 17 minutes 39 seconds West, distance of 343.28 feet to a point; thence 2) South 16 degrees 22 minutes 45 seconds West, passing a reference iron pin* at 18.27 feet, an iron pin* at the northeast corner of a 0.093 acre tract described in Volume 245 Page 824 of the Athens County Official Deed Records at 337.62 feet, for a total distance of 567.62 feet to an iron pin* on the northerly right of way of Northpoint Drive at the southeast corner of said Lot 5 and said 0.093 acre tract and southwest corner of said Lot 6; thence along the northerly right of way of Northpoint Drive and the south line of Lot 5 along a non-tangential curve to the right a distance of 84.35 feet, said curve has a radius of 92.62 feet, a central angle of 52 degrees 10 minutes 39 seconds, and a chord which bears North 81 degrees 48 minutes 34 seconds West a distance of 81.46 feet to a set iron pin; thence leaving said road and along a new property line the following three bearings and distances: 1) North 18 degrees 26 minutes 36 seconds East, passing a set iron pin on the 25 foot set-back line at 26.39 feet, for a distance of 352.73 feet to a set iron pin; thence 2) North 12 degrees 45 minutes 20 seconds East, a distance of 207.51 feet to a set iron pin; thence 3) North 24 degrees 33 minutes 51 seconds East, a distance of 367.67 feet to a set iron pin on the north line of said Lot 5; thence along the north line of Lot 5 South 70 degrees 00 minutes 22 seconds East, a distance of 82.06 feet to the POINT OF BEGINNING and containing 1.6230 acres. Said 1.6230 acre tract consists of all of a 0.093 acre tract in Lot 5 of the Northpoint Subdivision as described in Volume 245 Page 824 of the Athens County Official Deed Records, and 1.53 acres of Lot 5 of the Northpoint Subdivision as described in Volume 182 Page 570 of the Athens County Official Deed Records. 
