Situated in Farm Lot 48 of the southwest quarter of Section 11, Town 9, Range 14, City of Athens, Athens
Township, Athens County, Ohio and described as follows:

Commencing at a found iron pipe* at the southeast corner of Lot 3074 of the Terrace Heights Subdivision and on the west right of way of Columbus Road; thence along the west right of way of Columbus Road the following four bearings and distances South 2 degrees 16 minutes 41 seconds East, a distance of 135.00 feet to an iron pin set*; thence continuing South 2 degrees 16 minutes 41 seconds East along said line, a distance of 37.48 feet to a found iron pipe*; thence South 6 degrees 08 minutes 51 seconds West, a distance of 97.52 feet to an iron pin set*; thence continuing South 6 degrees 08 minutes 51 seconds West along said line, a distance of 135.00 feet to an iron pin set at the southeast corner of a 0.78 acre tract described in Volume 239 Page 171 of the Athens County Official Deed Records THE TRUE POINT OF BEGINNING; thence continuing South 6 degrees 08 minutes 51 seconds West along said west right of way line of Columbus Road, a distance of 135.00 feet to an iron pin set; thence leaving the west right of way of Columbus Road South 74 degrees 50 minutes 54 seconds West, a distance of 257.89 feet to an iron pin set; thence South 84 degrees 04 minutes 36 seconds West, a distance of 123.20 feet to an iron pin set; thence North 18 degrees 40 minutes 32 seconds East, a distance of 130.80 feet to and iron pin set; thence North 75 degrees 16 minutes 23 seconds East, a distance of 92.50 feet to an iron pin set at the southwest corner of the aforementioned 0.78 acre tract; thence continuing North 75 degrees 16 minutes 23 seconds East along the south line of said 0.78 acre tract, a distance of 263.23 feet to the point of beginning and containing 1.0634 acres, and being a part of a 8.13 acre tract described in Volume 201 Page 901 of the Athens County Official Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar, 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer P.L.S. 6765.


