Thence South 05 37'03" West a distance of 772.81 feet to a 5/8" iron pin set;

Thence North 85 00'00" West a distance of 295.55 feet to the principal point of beginning containing 5.232 acres+ subject to all legal easements and rights-of-way.

Bearings were derived from the South line of Elliotsville as North 85 00'00" West.


