0.1061 ACRE TRACT

Being a part of the tract of land in the name of Marsha K. Ham as recorded in Official Record 415 at page 233, Athens County Recorder's Office, said tract being in Lot 5 Revised as recorded in said Official Record 415 at page 233 and in Lot 5 in the subdivision of Blackburn Woods Subdivision recorded in Slide 550 Page A & b, said tract being situated in the City of Athens, Athens Township, Section 14, T9N, R14N, Athens County, State of Ohio, and more particularly described as follows:

Beginning at a 5/8" iron pin with a 1-1/4" plastic identification cap stamped "Sands-Decker" found on the southwest corner of Lot 5 Revised;

Thence along the west line of said lot North 18 degrees 43 minutes 47 seconds West a distance of 68.86 feet to a 5/8" iron pin found on the northeast corner of a tract as recorded in Official Record 438 at page 1412;

Thence continuing along the west line of Lot 5 Revised North 15 degrees 55 minutes 33 seconds West a distance of 77.54 feet to a 5/8" iron pin with a 1-1/4" plastic identification cap stamped "Sands Decker" found;

Thence South 45 degrees 32 minutes 13 seconds East a distance of 129.45 feet to a 5/8"x30" iron pin with a 1-1/4" plastic identification cap stamped "PS 6044" set on the south line of Lot 5 Revised;

Thence along the south line of Lot 5 Revised, South 44 degrees 56 minutes 27 seconds West a distance of 69.37 feet to the point of beginning, containing 0.1061 acre, more or less, subject to the easements of record pertaining to this tract;

This tract is to be held in continuous and contiguous ownership with the tract as recorded in Official Record 438 at page 1412 and not to be used as a separate building site.

The bearings used in this survey are based on monuments found on the south line of Lot 5 Revised as bearing South 44 degrees 56 minutes 27 seconds West and are for the determination of angles only.

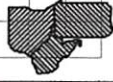

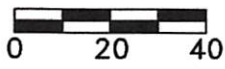
