## TRANSFER BETWEEN ADJOINING OWNERS PARCEL 2

Situated in Lot 2300 of W. S. Blackwood's Subdivision of Inlot No. 494 of the H. T. Brown Addition to the City of Athens, Athens County, Ohio and described as follows:

Commencing at a 3/4" iron pipe found at the northwest corner of said Lot 2300 of W. S. Blackwood's Subdivision of Inlot No. 494; thence along the north line of said Lot 2300, South 66 Degrees 30 Minutes 00 Seconds East for a distance of 11.34 feet to a set iron pin at THE TRUE POINT OF BEGINNING of this tract; thence continuing along the north line of said Lot 2300, South 66 Degrees 30 Minutes 00 Seconds East for a distance of 12.40 feet to a 1-1/4" iron pin found at the northeast corner of said Lot 2300; thence along the east line of said Lot 2300, South 14 Degrees 05 Minutes 49 Seconds West (passing a found 3/4" iron pipe at 14.12 feet) for a total distance of 110.82 feet to a point in the north right of way line of West State Street for the southeast corner of said Lot 2300; thence along said north right of way line of said West State Street, North 64 Degrees 21 Minutes 11 Seconds West for a distance of 21.54 feet to a point; thence leaving said right of way on a new line, North 18 Degrees 46 Minutes 11 Seconds East (passing a set iron pin at 8.03 feet and at 46.86 feet) for a total distance of 108.90 feet to THE POINT OF BEGINNING containing 0.042 acres and being a part of Lot 2300 as described in Volume 243, Page 808, Athens County Official Records.

To be continuous and contiguous with the remainder of Inlot 494 as described in Volume 243, Page 808, Athens County Official Records.

Note: Unless otherwise noted all set iron pins are 5/8" in diameter rebar, 30 inches in length and capped with a plastic identification marker inscribed L. F. Swoyer P.S. 6765.


