Situated in Lease Lot 50, Section 17, Athens City, Athens Township, Town 9, Range 14, Athens County, Ohio and described as follows:

Commencing at a stone* at the southeast corner of Lease Lot 68; thence on an assumed bearing South 52 Degrees 27 Minutes 42 Seconds West a distance of 535.98 feet to a point in Columbus Road on the grantor's east line at the southeast corner of a 0.906 acre tract described in Volume 298 Page 1825 of the Athens County Official Deed Records, THE TRUE POINT OF BEGINNING: thence leaving said road and along the grantor's north line and the south line of said 0.906 acre tract South 51 Degrees 25 Minutes 41 Seconds West ,passing a found iron pin ("Canter 7226" I.D.cap) which is 0.08' right at +21.64 feet, and the southwest corner of said 0.906 acre tract at 263.24 feet. for a total a distance of 450.00 feet to a set iron pin ; thence along a new line the following two bearings and distances: 1) South 38 Degrees 26 Minutes 25 Seconds East a distance of 180.00 feet to a set iron pin ; thence 2) North 51 Degrees 25 Minutes 41 Seconds East, passing a set P.K. nail at 438.48 feet, for a total distance of 450.00 feet to a point in aforesaid Columbus Road: thence along said road North 38 Degrees 26 Minutes 25 Seconds West a distance of 180.00 feet to the POINT OF BEGINNING and containing 1.859 acres Tract I of the tracts of land described in Volume 228 and being part of Page 205 of the Athens County Official Deed Records.

*Denotes calculated location of monument based on a previous survey.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed " L.F. SWOYER PS 6765."


