## Description of survey for Mark Spezza Seigle Lane Tract 1

Being a part of tracts of land transferred to Bonnie H. De Lange as recorded in Official Records Volume 486 at page 2569 Athens County Recorder's Office, Athens County, Ohio, also being a part of Farm Lots 10 and 12, Section 2, Township-9, Range-14, Athens Township, Athens County, State of Ohio and more particularly described as follows;

Beginning at a point on the north line of the grantor which bears South01°35'31"West, a distance of 283.80 feet from the assumed northwest corner of said Lot 10, Section 2, T-9, R-14;

Thence along said north line South85°17'48"East, a distance of 275.22 feet to a 5/8" iron pin set on the west line of a tract transferred to Charles and Ruth Overby as recorded in Official Records Volume 283 at page 1035;

Thence leaving said north line and along said west line South01°35'31"West, a distance of 577.20 feet to an existing iron pin being the southwest corner of said Overby tract;

Thence leaving said west line and thru the lands of the grantor the following three courses;

- 1. South65°45'19"West, a distance of 342.55 feet to an existing iron pin;
- 2. South49°27'35"West, a distance of 49.37 feet to an existing iron pin being the northwest corner of a tract transferred to Robert Hughes as recorded in Official Records Volume 504 at page 1489;
