RESTRICTIVE AGREEMENT

As a part of the consideration for this conveyance and in consideration of the incorporation of like covenants in any and all conveyances of other tracts by grantors from lands they presently own fronting on Longview Heights Road, Athens, Ohio, the grantees herein, for themselves, their heirs, executors, administrators and assigns, hereby covenant and agree to and with the said grantors, their heirs and assigns, for the use and benefit of said grantors, their heirs and assigns, and of every other person who shall or may become the owner of, or have any title derived immediately or remotely from, through or under the said grantors, their heirs and assigns, to any lot or parcel of land situated in lands of grantors fronting on Longview Heights Road, Athens, Ohio, as follows:

- 1. Said premises shall be exclusively for residence purposes.
- 2. There shall not be erected, placed or suffered to remain on said premises any building or structure whatever other than one private dwelling house, designed and intended for the occupancy of one family only, with garage and/or other outbuildings appurtenant thereto, and such dwelling house, garage and/or other outbuildings shall be constructed, erected, placed, located and/or maintained only pursuant to, and in accordance with, all and singular the covenants and agreements of the grantees herein contained and not otherwise.
- 3. Such dwelling house shall be not less than one story in height above ground and shall contain not less than 2,100 square feet of living space, exclusive of garage, breezeway, basement and the like.

- 4. No part of such dwelling house, exclusive of open porches, shall be erected, placed or suffered to remain on said premises within 25 feet of the street or highway on which said premises front, nor within 10 feet of either side line of said premises.
- 5. No barn or stable and/or no billboard, sign or advertising device of any kind other than a "for sale" or "for rent" sign, shall be erected, placed or suffered to remain on said premises.
- 6. No garage or other outbuilding shall be erected, placed or suffered to remain on said premises within 25 feet of the street or highway on which said premises front, nor, without the written consent of the owner thereof, within 10 feet of the side line of any contiguous premises.
- 7. Said premises shall not be used for any purpose or in any way which may endanger the health or unreasonably disturb the quiet of any occupant of adjacent or neighboring premises.
